NOW, THEREFORE, it is hereby stipulated and agreed by and between the parties hereto, as part of the said contract and for the consideration therein set forth, that neither the undersigned Contractor, any subcontractors, materialmen, or mechanic, nor any other person furnishing labor or materials to the said Contractor under this contract shall file any mechanic's or other lien or claim for work done or material furnished in or about the performance of said contract against the ground upon which the structure or work herein provided for is erected or done or against any structure thereon erected or to be erected, or against any structure or property whatsoever covered by said contract.

THIS stipulation is specifically made with the purpose and intent that it be filed in the Prothonotary's Office of CLEARFIELD County, Pennsylvania, in accordance with and under and by virtue of an Act titled Mechanics' Lien Law of 1963, P.L. 1175, No. 497, as amended, in order to operate as a complete waiver by the Contractor and all subcontractors of the right to file any mechanic's liens, of any nature and in any manner.

Beginning at a point, said point being the at the intersection of the western Right-of-Way for North Sixth Street (50' R/W) and the northern Right-of-Way for East DuBois Avenue (50' R/W), and being the southeast corner of the herein described parcel,

THENCE; N 66 degrees 48 minutes W along the northern Right-of-Way for East DuBois Avenue (50' R/W) a distance of 318.06 feet to a point, said point being the southwest corner of the herein described parcel,

THENCE; N 23 degrees 15 minutes E along lands now or formerly The Pennsylvania State University (Instrument Number 200014033, dated May 8, 2000) a distance of 301.72 feet to a point, said point being the northwest corner of the herein described parcel,

THENCE; S 68 degrees 31 minutes E along the lands now or formerly The Pennsylvania State University (Deed Book 608 Page 088, dated September 22, 1972) a distance of 307.44 feet to a point, said point being the northeast corner of the herein described parcel,

THENCE; S 21 degrees 16 minutes W along the western Right-of-Way for North Sixth Street (50' R/W) a distance of 311.11 feet to the place of beginning.

Containing 95,806 square feet or 2.20 Acres

Being the same lands as described in Deed Book 712 Page 415, dated January 12, 1976, lands conveyed to the DuBois Educational Foundation
