4. That on or before August 31, 2001, the Defendant, did enter upon the property of the Plaintiff's without permission and did so remove coal, transport coal over and across Plaintiff's property and did deposit tons of spoil or overburden upon Plaintiff's property without permission or under a valid lease agreement.

5. That during Defendant's trespass upon Plaintiff's property and adjoining properties, the Defendant did unlawfully deposit tons of spoil or overburden without permission upon Plaintiff's property and failed to do so in compliance with current Federal, State and laws, regulations and local ordinances the same.

6. That during Defendant's trespass upon Plaintiff's property and adjoining properties, the Defendant may have caused or did cause the following to occur which will have an economic and environmental impact of Plaintiff's property:

a. Numerous tons of public waste to be buried on or near Plaintiff's property line without permission to do so and not in compliance with current Federal, State and laws, regulations and local ordinances governing the same.

b. Several gallons of water was permitted accumulate in the adjoining open pit which was on or near Plaintiff's property which was permitted to become stagnant, thus causing harm to source water for Plaintiff's property.


c. That the overburden or spoil so placed upon Plaintiff's property will add additional costs for future mining and make it economically impractical for the owners of the coal and Plaintiff to mine the remaining coal beneath the surface.


7. That the Defendant's conduct was willful and intentional.







Defendant, Leonard O. Swisher, Sr., by his undersigned
counsel, preliminarily object to Plaintiffs' Complaint as
follows:

**I. Preliminary Objection Raising Legal Insufficiency
of Plaintiffs' Complaint Pursuant to Pa.R.C.P. 1028(a)(4)**

1. Plaintiffs' Complaint alleges a cause of action
against Leonard O. Swisher, Sr., individually.

2. Plaintiffs' Complaint alleges correctly that a
trespass, if such occurred, was committed by Swisher
Contracting, Inc.

3. Plaintiffs' Complaint fails to allege any facts
upon which liability for the alleged trespass can be visited
upon Leonard O. Swisher, Sr., individually.

WHEREFORE, Defendant respectfully requests that your Honorable Court grant Defendant's preliminary objections by way of demurrer and dismiss Plaintiffs' Complaint.

II. Preliminary Objection Raising an Issue of Lack of Specificity Pursuant to Pa.R.C.P. 1028(a)(3)

4. Plaintiffs' Complaint alleges that Defendant committed an intentional trespass to Plaintiffs' property.

5. Plaintiffs' Complaint sets forth various claims as to the manner in which Plaintiffs' property was allegedly damaged.

6. Plaintiffs' Complaint fails to specify the following:


A. Monetary cost of restoring Plaintiffs' property provided said cost does not exceed the value of the land itself;

B. Extent to which Plaintiffs' water source was degraded;

C. Monetary cost of restoring or correcting the degradation of Plaintiffs' water supply; and

D. Monetary value of the coal in place that Plaintiffs claim to have lost.

WHEREFORE, Defendant respectfully requests that
Plaintiffs be directed to file a more specific pleading.

MOTION TO PRODUCE EXPERT REPORTS

AND NOW COMES James A. Naddeo, Esquire, attorney for
Defendants in the above-captioned matter, and sets for the
following:

1. That the Court conducted a Pre-Trial Conference in
this case on August 29, 2013.

2. That Counsel for Plaintiffs indicated that
Plaintiffs' claim was based on coal removed by the Defendant
from Plaintiff's property.

3. That Plaintiff has failed to produce a report or
other documents verifying that Defendant removed coal from
Plaintiffs' property.

4. That in fact no coal was removed by the Defendant
from Plaintiffs' property and to the contrary Defendant
inadvertently placed backfill material on Plaintiffs' property
as the result of a survey error.

5. That alternatively Plaintiffs claim a diminution in value of their property incident to Defendant's inadvertent trespass.

6. That Plaintiffs have failed to produce an expert report as to the before and after value of Plaintiffs' property incident to any alleged damage caused by Defendant's inadvertent trespass.

7. That the property infringed on by Defendant has been previously stripped and was in a severe state of disrepair when Defendant placed backfill material on Plaintiffs' property.

8. That Defendant was required by the Pennsylvania Department of Environmental Protection to reclaim the spoil placed on Plaintiffs' property in accordance with DEP Mining Regulations.


9. That it is believed and therefore averred that the reclamation of Plaintiffs' property improved its value.

10. That Defendant has a right prior to trial to have any expert reports in the possession of Plaintiffs that establishes the removal of coal from Plaintiffs' property and the amount of any diminution in value of Plaintiffs' property caused by Defendant inadvertent trespass onto Plaintiffs' property.




