ALL that certain piece or parcel of land situate in the Borough of Houtzdale, County of Clearfield and State of Pennsylvania, bounded and described as follows:




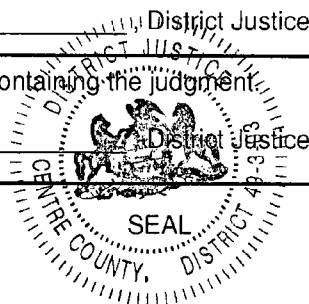
