## COMPLAINT

The Plaintiff, NATIONAL LEGAL RESEARCH GROUP, INC. by it's attorneys, **KNUPP, KODAK & IMBLUM, P.C.**, brings this action of Assumpsit against the Defendant to recover the sum of ONE THOUSAND, SEVEN HUNDRED SEVENTEEN DOLLARS AND SEVENTY-FOUR CENTS (\$1,717.74), along with interest thereon, upon a cause of action of which the following is a statement:

1. The Plaintiff, NATIONAL LEGAL RESEARCH GROUP, INC., is a corporation organized and existing under the laws of the state of Virginia, having its principal office and place of business at 2421 Ivy Road, Charlottesville, Virginia 22906-7187.

2. The Defendant, RONALD E. ARCHER, is an adult individual residing at 711 Hannah Street, Houtzdale, Clearfield County, Pennsylvania 16651.

3. On the dates, in the amounts, and for the prices set forth in a true and correct copy of the Plaintiff's Invoice hereto attached, marked Exhibit "A" and made a part hereof, Plaintiff performed labor and provided services of the kind and description set forth on said Exhibit to the total amount of One Thousand, Three Hundred Thirteen Dollars and Ninety-Three Cents (\$1,313.93).

4. The prices charged for said labor performed and services provided were just and reasonable, were the legal and market prices therefor and were the prices which the Defendant orally promised and agreed to pay to Plaintiff.

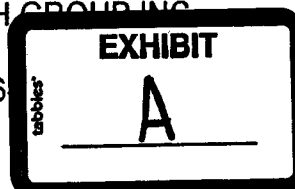

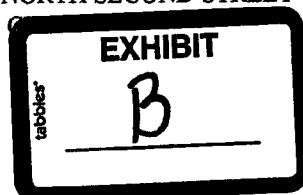
