On or about September 13, 1997, Petitioner purchased at Nationwide Auction Systems sold as the property of Wisconsin Flat Bed Equipment Trailer, Unit No. 199257, bearing Vehicle Identification No. 6934 for the base purchase price of \$1,400.00 together with a processing fee of \$50.00, buyers premium of \$140.00 and tax of \$7.71 for a total purchase price of \$1,664.55.

3. Petitioner has come to learn that Wisconsin Flat Bed Equipment Trailer purchased the vehicle which is a tandem axle from A & R Equipment Rental, 43925 John Mosby Highway, Chantilly, Virginia 22021.

4. Since 1997, your Petitioner has attempted to obtain a title for the tandem axle but has been unable to obtain one from Nationwide Auction Systems. To the best knowledge, information and belief of Petitioner, Nationwide Auction Systems went out

of business and was taken over by U. S. Rentals of California who later became part of United Rental.


5. Petitioner has attempted to locate Wisconsin Flat Bed Equipment Trailers but that company also appears to be out of business. No search on the internet reveals a company by that name.

6. Attached hereto is a tracing of the vehicle identification plate.

7. Petitioner is a holder in due course.
