C O M P L A I N T

NOW COMES the Plaintiffs, ALETHA M. LITTLE, and by her attorney, James A. Naddeo, Esquire, sets forth the following:

1. That the Plaintiff is Aletha M. Little whose address is 75 Cherry Drive, Frenchville, Pennsylvania 16836.

2. That the Defendant, Scott A. Martell, is a sui juris, adult individual whose address is 536 South Second Street, Apt. #3, Clearfield, Pennsylvania 16830.

3. That the Defendant, Barbara R. Martell, is a sui juris, adult individual whose address is P.O. Box 27, Surveyor Road, Shawville, Pennsylvania 16873.

COUNT I

Aletha M. Little vs. Scott A. Martell

4. That on or about November 11, 2001, at approximately 12:15 p.m. Plaintiff, Aletha M. Little, was a passenger in the right front seat of a 1998 Ford Truck bearing

Pennsylvania Registration No. YGY6833, which vehicle was operated by Thomas Moody.

5. That on the said date at or about the said time, the Defendant, Scott A. Martell, was the operator of a 1998 Ford Truck bearing Pennsylvania Registration No. YAL8898.

6. That State Route 879 is a 2-lane macadam road which proceeds in a generally East-West direction through Goshen Township, Clearfield County, Pennsylvania.

7. That on the said date at or about the said time, it was nighttime, there were no adverse weather conditions and the roadway was dry.

8. That on the said date at or about the said time, the vehicle in which the Plaintiff was a passenger was proceeding East on State Route 879 in its proper lane of travel.

9. That on the said date at or about the said time, the vehicle operated by Defendant, Scott A. Martell, was proceeding West on State Route 879.

10. That on the said date at or about the said time and at a point approximately 1.5 miles West of Shawville, Pennsylvania, the Defendant, Scott A. Martell, crossed over the double yellow line into the Eastbound lane of travel where he collided with the vehicle in which the Plaintiff was a passenger causing it to spin in a counterclockwise direction and slide 125' where it came to a rest in the Westbound lane facing South.

11. That as a result of the collision described in Paragraph 10 hereof, which is incorporated herein by reference, the Plaintiff was thrown generally forward and backward within the vehicle in which she was a passenger causing the numerous and serious injuries hereinafter set forth.

12. That the Defendant was guilty of the following negligence, recklessness and carelessness which was the proximate cause of the accident and the injuries received by the Plaintiff as follows:

A. The Defendant failed to have his vehicle under proper control;

B. The Defendant failed to maintain a proper lookout;

C. The Defendant violated the Motor Vehicle Code of 1976, June 17, P.L. Section 3714, 75 Pa.C.S.A. Section 3714, and supplements thereto, in that he operated his vehicle upon State Route 879 in careless disregard for the safety of the Plaintiff.

D. That the Defendant violated the Motor Vehicle Code of 1976, June 17, P.L. 162, Section 3361, 75 Pa.C.S.A. Section 3361 and supplements thereto, in that he operated his vehicle upon State Route 879 at a speed greater than was reasonable and prudent under the conditions then and there existing and without

regard to the actual and/or potential hazards then and there existing and at a speed which was greater than would permit him to bring his vehicle to a stop within the assured clear distance ahead.

E. That the Defendant violated the Motor Vehicle Code of 1976, June 17, P.L. 162, Section 3309, 75 Pa.C.S.A. Section 3309 and supplements thereto, in that he failed to operate his vehicle entirely within a single lane of a roadway laned for traffic without first ascertaining that the movement could be made with safety.

F. That the Defendant violated the Motor Vehicle Code of 1976, June 17, P.L. Section 3736, 75 Pa.C.S.A. Section 3736, and supplements thereto, in that he operated his vehicle upon State Route 879 in willful or wanton disregard for the safety of the person of the Plaintiff.

G. That the Defendant was negligent, careless and reckless in that he failed to use due care under all of the circumstances of the case.

13. That as a result of the negligence, recklessness and carelessness of the Defendant as set forth in Paragraph 12 hereof, which is incorporated herein by reference, the Plaintiff

received serious and extensive injuries which may and probably will be permanent as follows:

- A. Ligamentis sprain cervical spine;
- B. Bruising of sternum;
- C. Seatbelt injury - bruising across abdomen; and
- D. Multiple bruises and contusions - chest, shoulders, abdomen and right leg.

14. That the Plaintiff has or will be required to expend sums for the treatment of the injuries referred to in Paragraph 13 hereof and will continue to incur medical services for an indefinite period of time in the future, which expenses are not covered by insurance.

15. That as a result of the injuries referred to in Paragraph 13 hereof, which is incorporated herein by reference, the Plaintiff suffers serious and permanent physical impairment which substantially prohibits her ability to engage in the normal and usual functions which she enjoyed prior to the accident, including but not limited to her household duties, hobbies and social relationships.

16. That the Plaintiff claims a reasonable amount for the following:

A. A reasonable amount for pain and suffering; past, present and future;

B. Cost of replacing household services;

C. Privation and inconvenience due to the injuries and treatment, past, present and future;

E. Other damages allowable by law.


