**PETITION FOR CHANGE OF NAME**

TO THE HONORABLE COURT:

NOW COMES, Petitioner, Jennifer L. Bohensky, by and through her attorneys, The Hopkins Law Firm, respectfully requests that this Court order a change of name for her minor child as named herein, in accordance with 54 Pa. Cons. Stat. Section 701 et seq., and petitions the Court as follows:

1. The Petitioner is Jennifer L. Bohensky who resides at 1259 Treasure Lake, DuBois, Pennsylvania 15801.

2. The Petitioner is the mother of Alexander Christian White, who was born on March 15, 1997 and is six (6) years of age.

3. The natural father of Alexander Christian White is Donald John White who currently resides at R.D. #1, Box 667, Hazen, Pennsylvania.

4. From his birth on March 15, 1997, Alexander Christian White resided with his mother, Jennifer L. Bohensky.

5. The Petitioner's natural father, Donald John White, has not seen or contacted said minor child for several months and Alexander Christian White would like his last name to be the same as his natural mother.



Since mother's name is "Bohensky", Petitioner desires that the legal surname of her child be changed to "Bohensky" for classification purposes, to avoid confusion for the child now and in the future, and to establish a consistent and clear identity for the child. The Petitioner desires to legally change her child's name in order that he may bear the name of Alexander Christian "Bohensky".

7. There are no judgments or decrees of record or any other matter of like character that would be affected by granting of this Petition. This Petition is not induced by fraud or intent to cause injury or confusion.

8. Alexander Christian White, of course, has never been convicted of a crime, or declared delinquent or dependent nor ever placed on probation by any Court for any offense.

WHEREFORE, your Petitioner respectfully request your Honorable Court pursuant to the Act of December 16, 1982, P.L. 1309 No. 295, Section 2, 54 Pa.C.S.A. Section 701, to set a hearing on this Petition for purposes of considering a decree to change the name of Alexander Christian White to Alexander Christian Bohensky.




