

COMPLAINT IN CIVIL ACTION

1. Plaintiff, AUSTIN POWDER COMPANY (hereinafter "plaintiff") is a corporation with an address of 25800 Science Park Drive, Cleveland, OH 44122.
2. Defendant, ED HANSLOVAN COAL COMPANY INC. (hereinafter "defendant") is a corporation operating under the laws of the Commonwealth of Pennsylvania with offices at Box 230, Route 2, Morrisdale, Clearfield County, Pennsylvania 16858.
3. Between on or about February 22, 2002 and April 30, 2003, plaintiff, at the request of defendant sold and delivered certain goods at the times and in the amounts as fully set forth on plaintiff's statement of account, a true and correct copy of which is attached hereto, made a part hereof and marked as Exhibit "A".
4. The prices charged for the said goods were the fair, reasonable and market prices of the same at the time they were sold and delivered to the defendant and further are the prices it agreed to pay.
5. After all payments have been credited, an outstanding balance in the amount of \$12,037.72 remains due plaintiff by defendant but defendant has failed

or refused to pay the same or any part thereof despite repeated demands.

6. In addition to accruing principal, plaintiff demands interest at the legal rate of 6% per annum from May 1, 2003.
