

*of property for Release of Mechanics Lien in favor of Edward J. Hepfer and Connie L. Hepfer.*

All that certain piece or parcel of land situated in the Township of Lawrence, County of Clearfield, and the Commonwealth of Pennsylvania, more particularly bounded by and described as follows:

BEGINNING at the iron pin located on the East side of an access road which leads from Township Road No. 588 to Lot No. 3 and to an existing gas well. Said point is also the Northwest corner of Lot No. 2; thence along Lot No. 2 South twenty-three degrees, two minutes East (S 23° 02' E) one hundred eighty-one and forty-four hundredths feet (181.44) to an iron pin; thence along lands of, now or formerly, Thomas L. Harper, South thirty-eight degrees, fifty-three minutes, forty-five seconds East (S 38° 53' 45" E) five hundred two and sixty-five hundredths feet (502.65) to an iron pin on line of, now or formerly, Dudley and Nancy Lawhead; thence along lands of same, South sixty-three degrees, seventeen minutes, twenty-five seconds West (S 63° 17' 25" W) one thousand feet (1000.0) to an iron pin; thence along other lands of Grantors the following courses and distances, North twenty-six degrees, forty-two minutes, thirty-five seconds West (N 26° 42' 35" W) six hundred thirty-three feet (633.0) to an iron pin; thence North fifty-six degrees, twenty-eight minutes, five seconds East (N 56° 28' 05" E) five hundred fifty-three and eighty-seven hundredths feet (553.87) to an iron pin; thence North sixty-seven degrees, thirty-two minutes, ten seconds East (N 67° 32' 10" E) three hundred fifty-six and fifty-six hundredths feet (356.56) to an iron pin and place of beginning. Known as Subdivision Lot No. 3 on map prepared by P.R. Mondock for Shirokey Surveys and dated July 25, 2003. CONTAINING 14.4465 acres and being part of the same premises conveyed to SHANNON LAND AND MINING CO., and recorded in Clearfield under Instrument No. 200120846. The map for this subdivision being recorded as Instrument No. 200315127. The GRANTEES, their heirs, successors and assigns shall have the right to use the proposed access Right-of-Way, as shown on said map mentioned above, for access to the premises hereby conveyed for a roadway and utilities. The GRANTOR, their heirs, successors and assigns shall also have the right to use said access Right-of-Way for access to the residue of the parent tract.

EXCEPTING and RESERVING unto the GRANTORS herein the coal, minerals, oil, and gas as now owned by the GRANTORS. This conveyance is made subject to an oil and gas lease with Kriebel Resources as recorded in Deeds and Records book 1829 at page 414 et al.
