PETITION FOR APPOINTMENT OF SCHOOL POLICE

NOW COMES, the PHILIPSBURG-OSCEOLA AREA SCHOOL DISTRICT, by its solicitor, Winifred H. Jones-Wenger, who petitions the Honorable Court to appoint school police officers and in support of its petition avers as follows:

1. Petitioner is the Philipsburg-Osceola Area School District, a third-class school district, with its office located at 200 Short St., Philipsburg, (Clearfield County) Pennsylvania.

2. Petitioner desires that school police be appointed for the purpose of enforcing the school laws of the Commonwealth in its district, policing the grounds of the district and protecting the property of the district.

3. Pursuant to Section 778 of the School Code (24 P.S. 7-778), any school district may apply to any judge of the court of common pleas of the county in which such district is situated to appoint such person or persons as the board of directors may designate.

4. The Board of Directors has by Resolution dated September 22, 2003 requested that the Honorable Court appoint the following individuals as school police:


