**COMPLAINT**

AND NOW COMES Plaintiff, by their attorney, Kirby L. Boring, and files the following Complaint as follows:

1. Plaintiff is Nationwide Insurance Company as subrogee of Charles B. O'Connor, a company with offices and place of business at Box 2655, Harrisburg, PA 17105.
2. Defendant is Michael Craig Myers, an adult individual with a residential address of 3386 Allport Cutoff, Morrisdale, PA 16858 and a mailing address of R.D. #1, Box 500, Morrisdale, PA 16858.
3. At all times material, Charles B. O'Connor maintained a Policy of automobile insurance with the Plaintiff, made a claim for damages arising from the accident described below pursuant to said Policy, and was paid the amount set forth below for which payment the Plaintiff hereby seeks its subrogation reimbursement.
4. The accident herein described occurred on November 8, 2001 on State Route 1011, adjacent to Kylertown, Sunoco.

5. On the date and at the place above-described, the Plaintiff's subrogor was lawfully and carefully proceeding to make a right turn off the State Route into a parking lot, when his vehicle was struck from the rear by a vehicle owned by the Defendant.

6. The above accident was the sole and proximate result of the negligence of the Defendant in:


- a. Proceeding at a rate of speed unsafe under the conditions;
- b. Failing to observe the vehicle of the Plaintiff's subrogor and avoid same;
- c. Following too closely to the vehicle ahead; and
- d. Failing to bring his vehicle to a stop within an assured clear distance without striking the vehicle ahead.

7. As the sole and proximate result of the negligence of Defendant, Plaintiff's subrogor's vehicle was damaged in the amount of \$2,280.56.

8. Defendant has not responded to previous demands for payment of said damages.

WHEREFORE, Plaintiff demands judgment against Defendant in the amount of \$2,280.56, plus costs.
