PRE-ARBITRATION MEMORANDUM

AND NOW, comes Defendant, LINDA L. SHELDON, by her attorney, CHRISTOPHER E. MOHNEY, ESQUIRE, and files the following Pre-Arbitration Memorandum in accordance with Clearfield County local Rule 1306A, a statement of which is as follows:

1. **BRIEF STATEMENT OF THE CASE.** Plaintiff, Marlene B. Roy (hereinafter "Marlene") and Linda L. Sheldon (hereinafter "Linda") are sisters. Their mother is Elizabeth Roy, of whom is currently a resident of DuBois Village, an assisted living facility. Prior to her moving to the village, Elizabeth Roy gave Linda power as Agent pursuant to a Power of Attorney. Moreover, by Deed dated May 11, 2000, Instrument No. 200006476 recorded in the Clearfield County recorder of Deeds Office, Elizabeth Roy gifted her residence to Linda. Approximately one (1) year after being gifted the property, Linda caused to be auctioned Elizabeth Roy's personality within the home, and sold the residence, both to generate proceeds to fund Elizabeth Roy's stay at DuBois Village, which requires private-pay status.

The crux of Marlene's complaint appears to be that she had some sort of agreement with her mother, Elizabeth Roy, whereby Marlene stored various items at her mother's home, which

items she alleges Linda either kept, caused to be sold, or destroyed. Succinctly, Linda denies doing anything wrong, much less wrongfully denying Marlene from access to any property she had at her mother's home, be it before the property was deeded to Linda, or after (when she had every right to prevent Marlene access from the home, since Linda owned it). Linda denies being in any way liable to Marlene for any amount of money.


