STIPULATION OF THE PARTIES FOR PAYMENT
AND FOR THE ENTRY OF JUDGMENT BY CONSENT

TO THE PROTHONOTARY:

Kindly enter Judgment in favor of Plaintiff and against the Defendant, Janet E. Noker, above-named, in the amount of \$1,189.40 pursuant to the Stipulation of the Parties for Payment and for the Entry of Judgment by Consent, as follows:

1. Defendant admits indebtedness to Plaintiff in the amount of \$1,189.40 with continuing interest thereon at a rate of 6% per annum plus costs from April 8, 2004.
2. To secure the repayment of said indebtedness, Defendant agrees that Judgment by Consent will be entered in favor of the Plaintiff and against the Defendant, Janet E. Noker, in the amount of \$1,189.40 plus continuing interest thereon at the rate of 6% per annum from April 8, 2004 and costs.

3. Plaintiff agrees not to Execute on its Judgment so long as Defendant causes to be delivered to Plaintiff the following payments in full by 12:00 NOON on the following dates:

(a) \$50.00 due by April 20, 2004;

(b) no less than \$50.00 per month due on the 20th day of May and June at that time, no less than \$137.00 per month due on the 20th until the Judgment amount plus accrued interest and costs are paid in full.

7. 
