COMPLAINT IN CIVIL ACTION

1. Plaintiff, Ganz, Inc. is a corporation having an office in North Tonawanda, NY.
2. Defendant, Cheryl A. Rake is an individual trading as Maggie Mae Mercantile doing business at: DuBois Mall, DuBois, PA 15801.
3. On or about June 28, 2002, Defendant, Cheryl A. Rake executed a Credit Application ("Application") with Plaintiff to enable it to rent Plaintiff's goods and equipment on credit.
4. A true and correct copy of the Application is attached hereto, made a part hereof and marked as Exhibit "1".

5. After receiving the aforementioned executed Credit Application, Plaintiff did agree to sell goods and materials to Cheryl A. Rake i/t/a Maggie Mae Mercantile with the understanding that the terms and conditions would be met.

6. Plaintiff, at the request of the Defendants, sold and delivered certain goods at the times and for the amounts set forth on Plaintiff's Statement of Defendant's Account, a copy of which is attached hereto, made a part hereof, and marked as Exhibit "1".

7. The prices charged for the goods were the fair and reasonable market prices of the same at the time they were sold and delivered to the Defendant, and further are the prices the Defendant agreed to pay.

8. Plaintiff has demanded payment of the balance due as set forth on Plaintiff's Invoices of Defendants account, Exhibit "1", of Six Thousand Eight Hundred Thirteen and 01/100 Dollars (\$6,813.01), but Defendant has failed and refused to pay the same or any part thereof.

9. By the terms of sale, Plaintiff is entitled to interest at a rate of 12% per annum which became due and payable from an average due date of November 14, 2003.

10. Finally in accordance with the parties agreement Plaintiff is entitled to recover its reasonable and actual attorney's fees of \$1,666.99.

WHEREFORE, Plaintiff demands judgment in its favor and against the Defendant in the sum of Six Thousand Eight Hundred Thirteen and 01/100 Dollars (\$6,813.01) interest at a rate of twelve percent (12%) per annum thereon from November 14, 2003, attorneys fees of \$1,666.99 together with cost.




