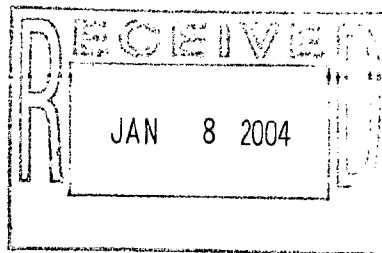
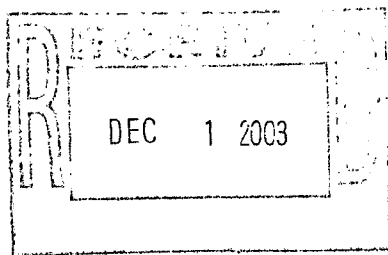

The above named plaintiff(s) asks judgment against you for \$1,067.08, inclusive of interest, reasonable attorney's fees and costs upon the following claim (Civil fines must include citation of the statute or ordinance violated):

Plaintiff issued a revolving credit account to Defendant under Account Number 4777210845021888, which was subject to terms and conditions as outlined and agreed upon by Defendant, which included, but were not limited to, interest, reasonable attorney's fees, and all court and collection costs in the event of default in payment. Defendant utilized said revolving credit account to obtain extensions of credit which Defendant used for the purchase of products, goods and/or for obtaining services from Plaintiff and subsequently incurred a delinquent balance due and owing in the amount of \$660.01. Despite Plaintiff's reasonable and repeated demands for payment, Defendant has failed, refused and continues to refuse to pay all sums due and owing on Defendant's account balance, all to the damage and detriment of Plaintiff. To date, the balance due, owing and unpaid on Defendant's account with Plaintiff is \$660.01.
