


AND NOW, this 3<sup>rd</sup> day of March, 2004, the parties having agreed to the entry of this Order, it is the ORDER of this Court as follows:

3. The cost for the genetic testing and any related court costs shall be paid by Plaintiff ten (10) days in advance of the testing date.





AND FOR GENETIC TESTING**


NOW COMES, SCOTT A. MOORE, Plaintiff above named, and by and through his attorneys, Belin & Kubista, requests genetic testing and to establish paternity pursuant to 23 Pa. C.S.A. Section 4343 and in support of the request states that:

1. Plaintiff is an adult individual who resides at R.D. #4, Box 629, DuBois, Clearfield County, Pennsylvania.
2. Defendant is an adult individual who resides at Treasure Lake, DuBois, Clearfield County, Pennsylvania.
3. Defendant is the natural mother and Plaintiff believes he may be the natural father of the following child: Austin John Stankavich.
4. The above named child resides with the Defendant at Treasure Lake, DuBois, Clearfield County, Pennsylvania.
5. Defendant was not married at the time the child was conceived and born.
6. Defendant is not now married.
7. There is not a custody, support or other action involving the paternity of the above named child now pending in any jurisdiction.

8. There has not been a determination by any court as to the paternity of the child in any prior support, custody, divorce or other action.

9. Plaintiff agrees to pay all costs associated with genetic testing directly to the testing facility in accordance with the procedures established by that facility.
