NOW COMES the Petitioner, DAVID W. CLARK, by and through his attorneys, Belin & Kubista, and petitions the Honorable Court for the change of name of his minor child, Haley Renee Williams, and avers as follows:

1. That Petitioner is David W. Clark, an adult individual, currently residing at 563 Marjorie Mae, State College, Centre County, Pennsylvania.
2. That Haley Renee Williams is one (1) year old (D.O.B. 2/14/03) and was born out of wedlock to Petitioner, David W. Clark, and Crystal M. Williams, natural father and natural mother.
3. That upon her birth, Haley Renee Williams was given the name of her mother.
4. That the Petitioner desires to legally change the name of his daughter, Haley Renee Williams, in order that the child may bear her father's name.
5. That during the course of the child's life, she has resided with her mother at 258 Keystone Hill Road, Philipsburg, Clearfield County, Pennsylvania. Petitioner has had regular periods of partial custody with the child since the entry of a Custody Order by this Court on December 8, 2003. Prior to that time, Petitioner saw the child informally by the agreement of the parties.
6. There are no judgements or decrees of record or any other matter of like character against Haley Renee Williams.






