

Now, comes the **Plaintiff, Gina R. Anderson** who hereby avers as follows:

1. Gina R. Anderson is an adult individual whose address is 214 Witmer Street, Clearfield, Pennsylvania 16830.

2. Defendant is Wal-Mart Supercenter with a local address is 100 Supercenter Drive, Clearfield, Pennsylvania 16830.

3. Gina R. Anderson is the owner of a 1994 Ford Explorer.

4. On Nov 12, 2003 I took my car to the Defendants which is Wal-Mart Supercenter to the Tire & lube to have my oil changed and have all fluids checked.

5. Following the oil change & fluids checked on November 12, 2003, Plaintiff operated her vehicle for a approximately 1 month without any noticeable problems.

6. But then on December 11, 2003 on my way to Ohio my car had a clucking noise and had no gears.

7. I had it towed by A.J. Ross Jr. Towing & Recovery, they towed it to JB's Garage.

8. On December 14, 2003 JB's Garage called me at work and explained the transmission was burnt up because of lack of gear oil.

9. I had explained to them that I had took my car to the Defendant which is Wal-Mart Supercenter Tire & Lube and I had my oil changed and fluids checked. The technician who

worked on my car said there was no way it was checked and advised me to file a claim at Wal-Mart.

10. I called the Defendants and filed a claim and they gave me a number to call which was the Claims Management, Inc. When I had talked to them they advised me that they was denying any claim for the Plaintiff's damages.

Plaintiff, believes and avers that the Defendant, and/or it's agents, are directly and solely liable for the Plaintiff's damages with respect to the damage to her transmission, including cost for towing, the cost for replacement of transmission and it's installation, loss of wages because of missing work & overtime that could of been able to work, paying gas money per day for a ride to and from work, car rental, mental anguish, filing fee's.

Plaintiff claims damages in the amount of 6,595.20 including costs, represented as follows:

- a). 424.29- car rental
- b). 60.00- towing
- c). 1,565.20- total bill for rebuilt transmission
- d). 460.00- gas money
- e). 1,395.00- loss of wages
- f). 118.50- filing fee
- g). 2,572.21- for mental anguish

Wherefore, the Plaintiff, Gina R. Anderson, demands judgement against the Defendant Wal-Mart Supercenter in the amount of 6,595.20 plus all court costs including District Justice Court, and other such reasonable costs as the court may allow.




