

COMES NOW, COUNTY NATIONAL BANK, appellee in the above-captioned matter by its attorney Peter F. Smith who respectfully states;

1. The Appellant Bonnie J. Witmer filed a Notice of Appeal from a Judgment entered in favor of County National Bank and against her and her former husband Kurt Witmer by District Magistrate Richard A. Ireland, Magistratrical District 46-32-02 in the amount of \$4,764.94 on March 1, 2004.

2. The Notice on Appeal was filed with the Clearfield County Prothonotary on March 15, 2004.

3. Attached hereto and incorporated herein by reference is a true and correct copy of Ms. Witmer's Notice of Appeal. The bottom proportion requesting that a Rule to file a complaint be entered by a Prothonotary has been crossed out and not completed.

4. No rule to file a complaint was issued which is contrary to PA.R.C.P.D.J. 1004.B. Thus the appeal is defective.

5. The Appellant's Proof of Service states that service of the notice was made on County National Bank on April 16, 2004, and the proof itself was filed on April 19, 2004. A true and correct copy of said proof is attached hereto and incorporated herein by reference.

6. PA.R.C.P.D.J. 1005.B. requires that the Appellant file the Proof of Service within 10-days after filing the Notice of Appeal.


7. In this instance, the Proof of Service should have been filed on or before March 26, 2004.
