WHEREAS, GREGORY S. KYLER and DEBRA L. KYLER, his wife, currently of 1384 Palestine Road, Morrisdale, Pennsylvania, 16858, about to execute contemporaneously herewith, a contract, with DAN CARTWRIGHT of CARTWRIGHT CONTRACTING, General Contractor, currently of 151 Substation Road, Morrisdale, Pennsylvania, 16858, for the construction of home improvements to a residential building upon premises situate in Graham Township, Clearfield County, Morrisdale, Pennsylvania, bounded and described as follows:

ALL that certain tract of land situate in Graham Township Clearfield County, Pennsylvania, bounded and described as follows:

**BEGINNING** at iron pin at intersection of Township Road leading to Deer Creek Road with township Road leading to Palestine School house; thence in a Northeasterly direction along first above mentioned Township Road a distance of Four hundred eighty feet (480) to another iron pin; thence in an Easterly direction along line of land of George Taylor Four hundred eighty feet (480) to jack pine; thence in Southwesterly direction Six hundred fifteen feet (615) more or less to iron pin at aforesaid road leading to Palestine School House; thence in Westerly direction along said last mentioned road Three hundred seventy two feet (372) more or less to place of beginning. **CONTAINS:** Approximately for (4) acres.





KYLER, his wife, it is agreed that no lien




