PETITION FOR CHANGE OF NAME

The Petitioner, TINA M. RUNYON, through undersigned Counsel, requests this Court to Order a Change of Name pursuant to 54 Pa. Cons. Stat. §7101 et seq., and in support thereof represents as follows:

1. The Petitioner is a resident of DuBois, Clearfield County, PA, who resides at 205 Forest Avenue, DuBois, PA 15801.

2. Your Petitioner is the natural mother of AHREN WILLIAM HURST, a minor, born on September 16, 1994, in DuBois, PA.

3. During the five years preceding the filing of this Petition, your Petitioner and her minor child resided at the following place's and during the following times:

(a) 205 Forest Avenue DuBois, PA 15801	For 2 years to present
(b) R. D. 2 (Sabula area) DuBois, PA 15801	For 2 to 3 years prior thereto
(c) On Route 255 in DuBois, PA 15801	For 1+ years

4. The father of the minor child subject to these proceedings is WILLIAM JOSEPH HURST. His whereabouts are unknown by your Petitioner.

5. Your Petitioner, TINA M. RUNYON, and the said father, WILLIAM JOSEPH HURST, were once married, but were divorced in the State of Georgia by Decree dated April 21, 1998.

6. With a certified copy of such Decree filed of record with the Prothonotary of Clearfield County, PA, at No. 2001-01510-CD, your Petitioner resumed her prior and maiden name of TINA RUNYON.

7. The natural father of said child has not had contact with said child since Christmas of 1995. Since then there have been no phone calls, no letters, cards, visits or any attempts by the natural father to contact your Petitioner and/or the minor child.

8. Nor has the family of the said natural father made any such attempts or shown any interest in the minor child.

9. There is currently an Order of Court with the Domestic Relations Section of your Honorable Court at No. 96-477-SD for the said natural father, WILLIAM J. HURST, to pay child support, although such amounts ordered in 1996 have never been paid, with the last such payment being collected sometime in early 2003 through Domestic Relations' enforcement efforts.

10. Currently, the Domestic Relations Section of Clearfield County, PA, does not know the whereabouts of the said natural father either, as they, as well as Petitioner have made reasonable efforts to discover the same. Said natural father's last known whereabouts was somewhere in California, one year ago.

11. The said AHREN WILLIAM HURST does not know his natural father, and has not had any contact with him since 1995 as aforesaid. Consequently, the said minor child has always associated with your Petitioner's family name, Runyon, and prefers to be known by such name.

12. In fact, until recently, in the DuBois Area School District, said minor child has been unofficially known as AHREN RUNYON, although no formal documentation or Court proceedings had ever formalized the same.

13. Further, the said minor child has associated his grandfather, Joseph Runyon, as his father figure, and has for most of his lifetime.

14. Said minor child, 9 years old at this time, has expressed a desire not only to formally assume the name of Runyon, but also to have his name changed from AHREN WILLIAM HURST, to AHREN JOSEPH RUNYON, because of his natural love and affection to his grandfather.

15. The purpose in filing this Petition for and on behalf of said minor child is not for the purposes of hiding his identity, or avoiding legal process or creditors, but is instead for the following purposes:

- (a) To nurture and fortify his self-esteem and self-image;
- (b) To assume the name of his mother, who is the only real parent that he has ever known;
- (c) To foster in him a sense of family pride and association; and
- (d) To avoid confusion as to the general public, friends and the school and school mates who know him by the name of "Runyon".

16. Your Petitioner believes that all of this is in the best interest of said child.

WHEREFORE, Petitioner prays your Honorable Court to enter an Order in the nature of the following:


- (a) Scheduling a Hearing on this matter and affixing a time, place and date for the same;

(b) To give Notice of the filing of this Petition and the date, time and place of this Hearing by publication in the Clearfield County Legal Journal, as well as the Courier-Express, which is a newspaper in general circulation in Clearfield County;

(c) To allow such advertisements to also serve as notice to the natural father, whose whereabouts are unknown and who cannot be notified by personal service, with such notice to be in the form attached hereto and identified as Exhibit "A";

(d) And after Hearing, enter an appropriate Order changing the name of said minor child from his current name, to the name of AHREN JOSEPH RUNYON.






