2. The adverse party is the Department of Transportation of the Commonwealth of Pennsylvania, having a mailing address of Department of Transportation, Bureau of Driver Licensing, P.O. Box 68693, Harrisburg, Pennsylvania 17106-8693.

3. Petitioner currently possesses a valid driver's license issued to him by the Department of Transportation that has not heretofore been suspended, cancelled, or revoked.

4. By letter or notice dated March 26, 2004, a copy of which is attached hereto labeled Exhibit "A", the Department of Transportation ordered Petitioner to surrender his operators license for a period of eighteen (18) months.

5. The said suspension of Petitioner's operating privileges is improper or unlawful for the following reasons:

- a. The suspension is not supported by the law;
- b. The suspension is not supported by the facts;
- c. Petitioner's refusal to submit to chemical testing was not voluntary;
- d. Petitioner did not receive adequate warning of his obligation to take a blood test exam;
- e. Petitioner was not operating a motor vehicle at or near the time requested to submit to chemical testing; and
- f. Petitioner's arrest was without probable cause and without citation.





MOTION FOR REINSTATEMENT OF APPEAL
NUNC PRO TUNC AND REPLY TO MOTION TO QUASH

AND NOW, comes the Appellant, Thomas L. Coccimiglio, by his attorneys, Hanak, Guido and Taladay, and hereby brings the within Motion for Reinstatement of Appeal Nunc Pro Tunc and Reply to Motion to Quash as follows:

1. On April 23, 2004, Appellant/Petitioner, Thomas L. Coccimiglio, acting pro se, filed a statutory appeal from an 18 month operating privilege suspension at County Docket No. 2004-575-CD.

2. The appeal petition raised a meritorious defense to the suspension in that Thomas Coccimiglio, having been injured in an automobile accident, did not have the cognitive capacity to knowingly refuse chemical testing. Apparently a hearing on this appeal was held on or about November 10, 2004. However, Appellant/Petitioner received no notice of this hearing because of a breakdown in the Court system.

3. Unaware of the hearing and Court ruling dated November 10, 2005, the Appellant again received a Notice of License Suspension dated January 10, 2005.

4. At the time of receipt of the Notice of January 10, 2005, the Appellant/Petitioner was represented by the firm of Hanak, Guido and Taladay with regard to criminal charges pending before this Court. The Appellant/Petitioner requested the law firm to file an appeal of the license suspension.

5. On behalf of the Appellant/Petitioner, the law firm of Hanak, Guido and Taladay, filed an appeal from the January 10, 2005 suspension notice, unaware of the ruling of November 10, 2004, believing this appeal to be a primary appeal of a chemical test refusal suspension.

6. On August 30, 2005, the Commonwealth of Pennsylvania, Department of Transportation by Office of Chief Counsel filed a Motion to Quash Appeal pending at No. 2005-187-CD. Only upon the receipt of this Motion did the Appellant/Petitioner and the law firm of Hanak, Guido and Taladay become aware of the prior Court ruling of November 10, 2004.

7. Appellant/Petitioner believes that he is entitled to nunc pro tunc consideration of the license suspension appeal filed at No. 2004-575-CD in that he had previously not been provided with notice of the suspension hearing or the Court's ruling.

8. For the reasons set forth above, the Petitioner/Appellant seeks the following relief:

(a) An Order of Court denying Motion to Quash Appeal pending at No. 2005-187-CD.

(b) An Order of Court vacating the Order of November 10, 2004 and granting Petitioner/Appellant nunc pro tunc relief in the form of a hearing de novo regarding the merits of this appeal from license suspension by reason of the chemical test refusal.

(c) Such other relief as the Court may deem appropriate.

1. On Nov. 10, 2004 the Court of Common Pleas entered an order Dismissing Petitioners Appeal. A copy of the order is attached as Exhibit "A."

2. The prothonotary of CLEARFIELD County Court of Common Pleas negligently failed to serve copies of the order on the petitioner.

3. The relevant docket entries, a copy of which are attached as Exhibit "B," contain no entry reflecting that notice of the order was given pursuant to Pa. R.C.P. 236.

4. Petitioner was required to file this appeal within thirty (30) days after entry of the order.

5. Petitioner was prevented from learning of the entry of the order and filing a timely appeal by reason of the negligent conduct of the prothonotary.

6. Petitioner first learned of the order when he on or about September 19, 2005 received a documentation from prior Counsel of a Motion To Quash Appeal filed by The Commonwealth and having The Aforementioned Nov.10, 2004 Order Attached Thereto.
