
COMPLAINT

1. Plaintiff is a corporation with offices in 1999 BROADWAY, STE 2150, DENVER, CO 88202.
2. Defendant is residing at RR 4 BOX 176, DU BOIS, PA 15801..
3. Defendant applied for and received a credit card issued by Plaintiff's assignor bearing the account number 5260312360057668.
4. Defendant made use of said credit card and has currently a balance due and owing to Plaintiff, as of April 8, 2004, in the amount of \$3,743.18. A true and correct copy of Plaintiff's Statement of Account is attached hereto, marked as Exhibit "1" and made a part hereof.
5. Defendant is in default of the terms of the cardholder Agreement having not made monthly payments to Plaintiff thereby rendering the entire balance immediately due and payable.
6. Plaintiff avers that the Cardholder Agreement between the parties provides that Plaintiff is entitled to the addition of finance charges at the rate of 24.99% per annum on the unpaid balance.
7. Although repeatedly requested to do so by Plaintiff, Defendant has willfully failed and/or refused to pay the principal balance, finance charges or any part thereof to Plaintiff.

WHEREFORE, Plaintiff demands Judgment in its favor and against Defendant, Richard Butler, individually, in the amount of \$3,743.18 with continuing finance charges thereon at the rate of 24.99% per annum from April 8, 2004 plus costs.
