

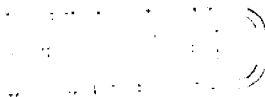

to defraud; and the Fourth Count asserts a breach of fiduciary duty claim. On December 17, 2001, this Court accepted the findings of a Special Panel appointed by this Court recommending that Plaintiff's derivative claims against C&M be dismissed based upon their determination that Defendant Richard J. Corman acted with sound business judgment, and dismissed Plaintiffs' derivative claims. This Order resulted in a dismissal of the Fourth Count of Plaintiffs' Second Amended Complaint which sets forth a claim for breach of fiduciary duty "of those defendants to the C&M," as well as the derivative claims contained in the remaining Counts. On January 26, 2001, in response to preliminary objections filed by defendants, this Court entered an Order dismissing the Second Count and Third Count of Plaintiffs' Second Amended Complaint. Plaintiffs subsequently filed a Motion for Leave to File a Third Amended Complaint and to Conduct Limited Discovery With Respect to the Purported Merger of October 29, 2001, which this Court denied in an Opinion and Order dated February 7, 2002. In the same Opinion and Order, this Court granted the Motion for Summary Judgment filed by Defendants Buffalo, Rochester & Pittsburgh Railway Company, Buffalo & Pittsburgh Railroad, Inc., CSX Transportation, Inc. and Consolidated Rail Corporation (the "Railroad Defendants") with respect to Plaintiffs' Breach of Contract claims arising after February 1997, and denied their Motion for Summary Judgment with respect to Plaintiffs' Breach of Contract Claims arising before February, 1997. As a result of the foregoing, only the First Count of Plaintiffs' Second Amended Complaint, as circumscribed by the February 7, 2002 Order, remains at issue in this litigation.

Now Motions For Summary Judgment have been filed on behalf of Defendant Richard J. Corman ("Defendant Corman") and R. J. Corman Railway Company/Pennsylvania Lines,
