PETITION FOR INVOLUNTARY TRANSFER OF OWNERSHIP

AND NOW, comes your Petitioner, CHARLES E. SHESTAK, through his Attorney, David P. King, and in support of his Petition avers as follows:

1. The Petitioner is CHARLES E. SHESTAK, an adult individual, residing at 630 Treasure Lake, DuBois, PA 15801, which is in Clearfield County.

2. On or about May 1, 2003, your Petitioner did purchase, from Star Auto, of 916 King Road #B, Nampa, ID 83687, one 1991 Nissan 300ZX Twin Turbo automobile bearing Vehicle Identification No. JN1CZ24H5MX502579. A copy of the Bill of Sale for the same is attached hereto as Exhibit "A".

3. The said vehicle was a totally demolished vehicle which had been acquired by Star Auto from Geico Casualty Insurance Company in the State of Washington, County of King, for a salvage value. A copy of the Bill of Sale into Star Auto is attached hereto and marked as Exhibit "B".

4. At the time Geico Casualty Insurance Company transferred the said vehicle per Bill of Sale to Star Auto, the Title to the vehicle, which was titled in the State of Washington, was completely canceled, as the same was a complete loss, and this being the procedure followed in such matters.

5. Your Petitioner had acquired the vehicle to restore the same so that it would be usable, and could be inspected, licensed and titled by the State of Pennsylvania for his personal use.

6. In fact, your Petitioner did restore the vehicle, after extensive work and cost, and thereafter attempted to obtain a reconstructed vehicle Title to be issued by the Pennsylvania Department of Transportation.

7. In fact, your Petitioner did submit MV-426 (02-01) form for that purpose to the Commonwealth of Pennsylvania and paid all the fees required for the same, as well as providing proof of insurance, as well as providing certification that the vehicle had been inspected and would comply in all respects with the Department of Transportation regulations.

8. Notwithstanding, the said Application for Reconstructed Vehicle Title was returned by the Pennsylvania Department of Transportation which could not process the same as the vehicle had been originally titled in the State of Washington as aforesaid.

9. Thereafter, your Petitioner did contact his State Representative Dan A. Surra, and through his efforts, it was determined that the proper procedure in this matter would be a Petition to your Honorable Court for the Involuntary Transfer of Ownership of a Vehicle, rather than an Application for Reconstructed Vehicle Title.

10. The procedure to be followed in this case is as per Petition to your Honorable Court, with notice to the appropriate party or parties in interest.


11. The original owner of the subject matter vehicle titled in the State of Washington is unknown to your Petitioner, and impractical, if not impossible to discern because title to the same no longer exists.

12. However, your Petitioner, through Legal Counsel, did contact Star Auto, who verified the circumstances as set forth herein, and their

willingness to cooperate in anyway so that CHARLES E. SHESTAK, who purchased the vehicle from Star Auto, may be able to obtain a proper Title to the vehicle through the Pennsylvania Department of Transportation.

13. Thus, for practical and legal purposes, it is averred herein that Star Auto is the only party in interest that can be ascertained or that needs to be notified of these proceedings.

WHEREFORE, Petitioner prays your Honorable Court to enter an appropriate Order awarding him ownership of the subject matter vehicle, and extinguishing the right, title and interest of any other person in said vehicle so that your Petitioner may obtain the Title from the Department of Transportation accordingly, and he will so ever pray.






