COMPLAINT

1. Plaintiffs are Dean D. Lansberry and Linda S. Lansberry, husband and wife, adult individuals residing at 205 Michlin Avenue, Curwensville, Clearfield County, Pennsylvania 16833.
2. Defendants are Charles E. Patton and M.B. Patton, also known as Mary B. Patton, husband and wife, both deceased, and John W. Patton, Rebecca Patton, and Honora Jane White, their heirs, executors, administrators and assigns, and all other persons, corporations, associations, or other entities claiming title under them.
3. The property which is the subject of this action is situated in the Borough of Curwensville, Clearfield County, Pennsylvania, and has been erroneously

identified as being Lot No. 92 in Patton's Addition throughout Plaintiff's chain of title. The said property is in fact Lot No. 91 in the said Patton's Addition and is accurately described as follows:

BEGINNING at an iron pin set on the edge of Bailey Road in the Eastern half of the Patton Addition, said pin designating the line between Lot 90 and 91. Said pin is also located South twenty-seven (27°) degrees twenty-three (23') minutes sixteen (16") seconds West two hundred (200) feet from the Southeast intersection of Bailey Road and West Street; thence along Lot 90 south sixty-two (62°) degrees thirty-six (36') minutes forty-four (44") seconds East one hundred fifty (150) feet to a twenty (20) foot alley; thence along said alley South twenty-seven (27°) degrees twenty-three (23') minutes sixteen (16") seconds West fifty (50) feet to another iron pin on said alley at line of Lot 92; thence along said Lot 92 North sixty-two (62°) degrees thirty-six (36') minutes forty-four (44") seconds West one hundred fifty (150) feet to another iron pin set in the line of Bailey Road; thence along line of Bailey Road North twenty-seven (27°) degrees twenty-three (23') minutes sixteen (16") seconds East fifty (50) feet to the iron pin and place of beginning.

Said description encompasses seventy-five hundred (7,500) square feet, being Lot No. 91 in the Eastern Section of the Charles Patton Addition to the Second Ward of the Borough of Curwensville. Said description is further illustrated on a plat of survey made by Robert L. Kester, P.L.S., dated September 2, 1986, a copy of which is attached to the deed referenced herein below and filed in the Office of the Recorder of Deeds for Clearfield County. The bearings used are current magnetic bearings, and do not coincide with the bearings of the original Patton Addition, although the lines designated do coincide with the lines as shown on the Patton Addition to the Borough of Curwensville.

BEING the same premises conveyed to Dean D. Lansberry and Linda S. Lansberry, husband and wife, by deed of Marc R. Daniels and Lorraine Daniels, husband and wife, dated October 15, 1986 and recorded at Clearfield County Deed and Record Book 1118, Page 83.

4. The chain of title to the above described property is as follows:

a. By deed dated March 11, 1915, recorded at Deed Book 208, Page 301, Charles E. Patton and M. B. Patton, his wife, conveyed what is identified as Lot 92, but was actually Lot 91, of the Patton Addition to the Borough of Curwensville to William J. Bartell and Elizabeth Bartell, his wife;

- b. By deed dated April 20, 1915, recorded at Deed Book 208, Page 303, William J. Bartell and Elizabeth Bartell, his wife, conveyed what is identified as Lot 92, but what was actually Lot 91, of the Patton Addition to the Borough of Curwensville to I. Lynn Kester and Lydia S. Kester, his wife;
- c. By deed dated October 26, 1916, recorded at Deed Book 216, Page 574, I. Lynn Kester and Lydia S. Kester, his wife, conveyed what is identified as Lot 92, but what was actually Lot 91, of the Patton Addition to the Borough of Curwensville to Americo Abrino;
- d. By deed dated November 9, 1928, recorded at Deed Book 297, Page 44, Enos Abrino, guardian of Americo Abrino, an insane person, conveyed what was identified as Lot 92, but what was actually Lot 91, of the Patton Addition to the Borough of Curwensville to Josephine Abrino;
- e. By deed dated August 6, 1930, recorded at Deed Book 297, Page 46, Josephine Abrino conveyed what was identified as Lot 92, but what was actually Lot 91, of the Patton Addition to the Borough of Curwensville to Rosa Abrino;
- f. By deed dated September 9, 1963, recorded at Deed Book 504, Page 145, Rosa Abrino, now Rosa Zattoni, conveyed what was identified as Lot 92, but was actually Lot 91, of the Patton Addition to the Borough of Curwensville to Francis E. Abrino and Elda A. Rapp;
- g. By deed dated July 6, 1971, recorded at Deed Book 577, Page 238, Francis E. Abrino and Jayne M. Abrino, his wife, and Elda A. Rapp and

John Rapp, her husband, conveyed what was identified as Lot 92, but was actually Lot 91, of the Patton Addition to the Borough of Curwensville to David A. Collins and Karen F. Collins, his wife;

- h. By deed dated November 30, 1983 and recorded at Deed Book 924, Page 519, David A. Collins and Karen S. Collins, husband and wife, conveyed what was identified as Lot 92, but what was actually Lot 91, of the Patton Addition to the Borough of Curwensville to Karen S. Collins;
- i. By deed dated May 15, 1985 and recorded at Deed Book 1013, Page 272, Karen S. Collins conveyed what was identified as Lot 92, but what was actually Lot 91, of the Patton Addition to the Borough of Curwensville to Marc R. Daniels and Lorraine Daniels, husband and wife;
- j. By deed dated October 15, 1986 and recorded at Deed Book 1118, Page 83, Marc R. Daniels and Lorraine Daniels, husband and wife, conveyed the aforesaid parcel to Dean D. Lansberry and Linda S. Lansberry, Plaintiffs herein.

5. For more than twenty-one (21) years, Plaintiffs and their predecessors in title have been in open, exclusive, hostile, adverse and actual possession of the real property described herein above, said property being the aforesaid Lot 91 of the Patton Addition to the Borough of Curwensville.
6. Due to the error in the identification of the said real property as being Lot 92, when it was actually Lot 91, Plaintiffs believe and therefore aver that said error

which has been perpetuated throughout the chain of title for nearly one hundred (100) years, represents a cloud on their title.

7. Plaintiffs, through their predecessors in title, made adverse entrance on the said real property nearly one hundred (100) years ago and said adverse possession has continued through the present time.
8. Plaintiffs' adverse possession of the said real property, through their predecessors in title, has been adverse to all interest, which the Defendants set forth herein may have in the premises.

WHEREFORE, Plaintiffs pray as follows:

1. That Defendants and all persons claiming under them within twenty (20) days from service of this Complaint, institute an action of ejectment against the Plaintiff and that otherwise the Defendants and all persons claiming under them be perpetually enjoined from setting up any title to the said property; from impeaching, denying or in any way attacking the Plaintiffs' title to said property, from issuing or maintaining an ejectment of said premises or any part thereof;
2. For a Decree of this Court determining all adverse claims of Defendants and all persons claiming under them;
3. For said Decree to declare it adjudged that Plaintiffs own absolutely and are entitled to the quiet and peaceful possession of said property as against Defendants and all other persons claiming under them, that Defendants and all persons claiming under them have no estate, right, title, lien or interest in or to said property or any part thereof, and the title to said property be quieted in Plaintiff against all claims of Defendants and all persons claiming under them;

4. For said Decree to permanently enjoin Defendants and all persons claiming under them from asserting any right, title, lien or interest in or to said property or any part thereof adverse to Plaintiffs;
5. For costs of this action;
6. For such other relief as the Court deems just and proper.

Affiant further avers that he attempted to locate said Defendants, or their heirs, by checking the local telephone directories, voter registration records, and real estate records of Clearfield County. The above information was the only estate information on file in Clearfield County.




NOW COMES, Belin & Kubista, Attorneys for Plaintiffs, and move the Honorable Court as follows:
