
COMPLAINT

1. Plaintiff is a corporation with offices at 3311 Mill Meadow Drive, Hilliard, OH 43026.
2. Defendants are adult individuals residing at 1405 Walton Street, Philipsburg, PA 16866.
3. Defendants applied for and received a credit card issued by Plaintiff bearing the account number 6011002649531571 .
4. Defendants made use of said credit card and have currently a balance due and owing to Plaintiff, as of March 22, 2004, in the amount of \$3,670.86.
5. Defendants are in default of the terms of the cardholder Agreement having not made monthly payments to Plaintiff thereby rendering the entire balance immediately due and payable.
6. Plaintiff avers that the Agreement between the parties provides that Defendants will pay Plaintiff's attorneys' fees.
7. Plaintiff avers that such attorneys' fees will amount to \$500.00.
8. Although repeatedly requested to do so by Plaintiff, Defendants have willfully failed and/or refused to pay the principal balance, finance charges or any part thereof to Plaintiff.
