COMPLAINT

AND NOW comes Kruise Funeral Home, Inc., Plaintiff, by and through its attorney, Girard Kasubick, Esq., and files the following Complaint:

1. The Plaintiff is Kruise Funeral Homes, Inc., a corporation formed under the laws of the Commonwealth of Pennsylvania, having its principal place of business at 254 Lynn Street, P.O. Box 587, Madera, Pennsylvania 16661.

2. The Defendant is Randall Mick who resides at P.O. Box 196, Second and Spruce Streets, Madera, Pennsylvania 16661.

3. Plaintiff is in the business of embalming, providing viewing, and making other arrangements for burial of the deceased persons.

4. On or about July 21, 2002, Randall Mick contacted Plaintiff and talked to Debora A. Kruise and Frank A. Kruise to provide embalming, viewing, and make other arrangements for the burial of his wife, Bonnie Jean Mick.

5. On or about July 21, 2003, Randall Mick did sign and execute an agreement for burial services of his wife, Bonnie Jean Mick, which agreement was also executed by Debora A. Kruise on behalf of the Plaintiff, a copy of which is attached hereto and incorporated herein and marked Exhibit "A".

6. The Plaintiff did provide to the Defendant the services as charged on Exhibit "A" incorporated herein and attached hereto.

7. The prices charged by Plaintiff were fair, reasonable, and market prices that prevailed at the time of the agreement in Plaintiff's business.

8. The prices charged by Plaintiff were the prices the Defendant agreed to pay.

9. The total amount for all services performed by the Plaintiff is Five Thousand Six Hundred Fifty (\$5,650.00) Dollars, as shown on Exhibit "A" incorporated herein and attached hereto.

10. The Defendant or parties on his behalf have made payments in the amount of One Thousand Two Hundred Fifty-eight and 28/100 (\$1,258.28) Dollars leaving a balance due of Four Thousand Three Hundred Ninety-one and 72/100 (\$4,391.72) Dollars.

11. The agreement, being Exhibit "A" attached hereto and incorporated herein, contains a late charge provision of 1.5% per month for any unpaid balance after thirty (30)

days from the date of the date of the Agreement, which was July 21, 2002.

12. Plaintiff agrees they have not charged a late charge prior to January 1, 2004, but does desire to charge the late charge commencing January 1, 2004.

13. The late charges from January 1, 2004 to July 31, 2004 amounts to Four Hundred Eighty-two and 41/100 (\$482.41) Dollars.

14. The total amount of damages due the Plaintiff as of filing this Complaint is Four Thousand Eight Hundred Seventy-four and 13/100 (\$4,874.13) Dollars, plus additional late charges or interest, court cost, and attorney fees.


