**CONTRACTOR'S WAIVER OF LIENS**

THIS AGREEMENT, made and entered into this 12<sup>th</sup> day of July, 2004, by and between LORI L. SNYDER, of 105 Wood Street, DuBois, Clearfield County, Pennsylvania 15801, hereinafter "Owner", and WELCOME HOME CENTERS, INC., a corporation organized and existing under the laws of the State of Pennsylvania, with offices located on the DuBois/Brockway Road, Route 219, with an address of R.R. #2, Box 429A, Brockway, Jefferson County, Pennsylvania 15824, hereinafter "Contractor";

See Exhibit "A" which is attached hereto, incorporated herein, and made a part hereof as though fully set forth herein.

NOW, THEREFORE, INTENDING TO BE LEGALLY BOUND HEREBY, the parties do agree as follows:

1. The Contractor for itself and anyone else acting or claiming through or under it, intending to be legally bound hereby, does hereby waive and relinquish all right to file a mechanics' lien, claim or notice of intention to file any lien or claim, and does hereby covenant, promise and agree that no mechanics' lien or claim or other lien or claim of any kind whatsoever shall be filed or maintained against the improvements or the estate or the title of the Owner in the Property or the curtilage or curtilages appurtenant thereto, by or in the name of the Contractor or any subcontractor, materialmen or laborers for work done or materials furnished under the Contract or by any other party acting through or under them or any of them for and about the improvements or the Property or any part thereof, or on credit thereof, and that all subcontractors, materialmen and laborers on the works shall look to and hold Contractor personally liable for all subcontractors, materials furnished and work and labor done, so that there shall not be any legal or lawful claim of any kind whatever against Owner for any work done or labor or materials furnished under the Contract for and about the erection, construction and completion of the improvements or under any contract for extra work, or for work supplemental thereto, or otherwise.

2. The Contractor does hereby remise, release and waive for itself, subcontractor and materialmen the right under the Act of Assembly entitled the Mechanics' Lien Act of 1963 to file or enter on record any Mechanics' Lien or Liens against ALL that certain piece, parcel or lot of ground situate in the City of DuBois, County of Clearfield, State of Pennsylvania, more particularly set forth on Exhibit "A", attached hereto and made a part hereof.


3. This Agreement waiving the right of lien shall be an independent covenant and shall operate and be effective as well with respect to work done and materials furnished under any


supplemental contract for extra work in the erection, construction and completion of the improvements as to any work and labor done and materials furnished under the Contract.

4. In the event Contractor consists of more than one person, firm or corporation, the undertakings hereunder of each of such persons, firms or corporations shall be joint and several, and the word "Contractor" shall mean all or some or any of them. For purposes of this Agreement, the singular shall be deemed to include the plural, and the neuter shall be deemed to include the masculine and feminine, as the context may require. This Agreement shall be binding upon the parties hereto, their heirs, executors, administrators and assigns.

Exhibit "A"

**ALL** that certain piece, parcel or tract of land lying and being situate in the John Rumbarger Addition to the City of DuBois, Clearfield County, Pennsylvania, being bounded and described as follows, to wit:

BEGINNING at an iron pin on Wood Street, a distance of 76 feet southerly from the intersection of Wood Street and West Washington Avenue; thence from said iron pin along Wood Street South  $32^{\circ} 13'$  West a distance of 104 feet to an iron pin at Clinton Alley; thence along Clinton Alley South  $62^{\circ} 30'$  East a distance of 60 feet to an iron pin in line of lands now or formerly of the DuBois National Bank; thence along line of lands now or formerly of the DuBois National Bank and line of Lot No. 226 in said addition, North  $32^{\circ} 13'$  East a distance of 104 feet to an iron pin; thence North  $62^{\circ} 30'$  West 60 feet to an iron pin at Wood Street and the place of beginning.
