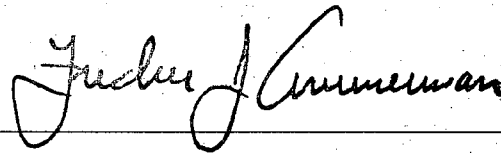

PETITION FOR CHANGE OF NAME

TO THE HONORABLE PRESIDENT JUDGE OF SAID COURT:

AND NOW, comes the Petitioner, **JOHNATHON SPURLOCK by PAMELA K. GLAZE, his mother,** by and through their attorney, Stephen W. French, Esquire, and files the following Petition to your Honorable Court of which the following is a concise statement:

1. Petitioner is PAMELA K. GLAZE, mother of JOHNATHON SPURLOCK, a minor, who presently resides at 105 Hanes Drive, Apt. 65, DuBois, Clearfield County, Pennsylvania 15801. Petitioner has resided in Clearfield County since February 20, 2002.

2. The minor Petitioner, Johnathon T. Spurlock was born on April 16, 1999. Petitioner's Birth Record is attached hereto to form a part hereof for more particular reference thereto, and identified as Exhibit "A" to the Petition.

3. Petitioners request your Honorable Court to enter an Order changing Petitioner's name, pursuant to 54 Pa. C.S.A. Section 701, et seq., from Johnathon T. Spurlock to Johnathon T. Glaze.

4. Petitioner desires to change his name from "Spurlock" to "Glaze" because he wishes to be known by the same name as his mother and because the name "Spurlock" is not respected in the community and the petitioner believes that the reputation connected with this name is detrimental to the child. Johnathon already identifies himself to his peers as Johnathon T. Glaze and wishes to make this change legally.

5. Father, Robert Spurlock, objects to this change of name for his child.

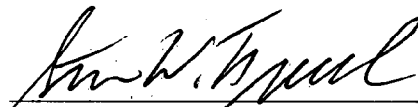
5. There are no judgments or decrees of record against the Petitioner as he is a minor, and Petitioner is not requesting that his name be changed for the purpose of concealment of identity or for any fraudulent purpose.

6. Petitioner has never been convicted of a criminal offense and is not subject to the prohibitions of Pa.C.S.A. Section 702(c).

7. Proper notice of the filing of the within Petition and the date of the Hearing scheduled on this Petition shall be published in accordance with law.

WHEREFORE, Minor Petitioner prays that this Honorable Court will enter a Decree changing his name from Johnathon T. Spurlock to Johnathon T. Glaze.

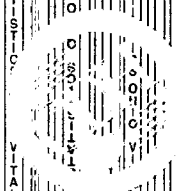

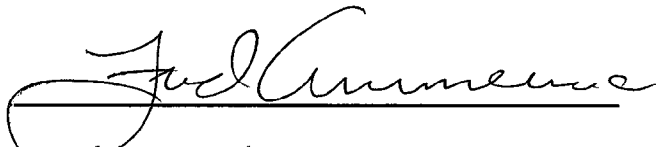
