COMPLAINT

Plaintiff, Allstate Insurance Company, as subrogee of Sandra Simpson, by and through their attorneys, White and Williams LLP, by way of Complaint against defendant, Bath & Body Works/White Barn Candle Company, hereby states the following:

1. Plaintiff, Allstate Insurance Company (hereinafter "Allstate"), is a corporation organized and existing under the laws of the State of Illinois. Allstate is authorized to conduct business and does conduct business in the Commonwealth of Pennsylvania.

2. At all times relevant hereto, Sandra Simpson, is an adult individual who owns property located at 35 Mowery Lane, Dubois, PA 15801 and insured this property with a policy issued by Allstate.

3. Defendant, Bath & Body Works/White Barn Candle Company (hereinafter "Bath & Body Works"), upon information and belief is a corporation duly organized and existing under the laws of the State of Ohio and which does conduct business in the Commonwealth of Pennsylvania.

COUNT ONE
NEGLIGENCE
PLAINTIFF VS. DEFENDANT

4. On September 16, 2003, a fire occurred at property owned by Sandra Simpson, which was located at 35 Mowery Lane, Dubois, Pennsylvania.

5. As a direct and proximate result of this September 16, 2003 incident, the property owned by Sandra Simpson and insured by plaintiff, Allstate, suffered extensive damages.

6. The above mentioned damages were caused, and resulted from the negligent, reckless and careless acts and/or omissions of defendant, Bath & Body Works, in designing and manufacturing a candle which caused the fire, White Barn Candle Company Real Essence Cucumber Melon Candle, product number 0452Z8A4B. Said acts consisted of:

- (a) Negligent design of the candle's glass container which housed the candle;
- (b) Negligent manufacturing of the glass container which housed the candle;
- (c) Negligent testing of the glass container which housed the candle to make sure it could withstand high thermal temperatures; and
- (d) Was otherwise negligent in designing, manufacturing and testing the candle and the glass container which housed the candle.

7. The above referenced fire damage to Simpson's property was caused by, and resulted from, the negligence, carelessness, recklessness and other liability-producing conduct of defendant as previously set forth and incorporated herein by reference in paragraph 6.

8. As a direct and proximate result of the foregoing and pursuant to its policy of insurance with Sandra Simpson, plaintiff, Allstate, incurred expenses in excess of \$100,000.00 when it indemnified Simpson for claims made under her policy due to the fire damage.

9. Pursuant to the application of the policy deductible, Sandra Simpson sustained uninsured losses of \$250.00.



As a direct and proximate result of defendant's negligent, reckless, careless acts and/or omissions, plaintiff, in indemnifying Simpson, incurred incidental and consequential damages including, but not limited to, repair and replacement expenses, loss of use of the building, and other consequential damages resulting in an amount in excess of \$100,000.00.



Authority For Civil Cover Sheet

The JS-44 civil cover sheet and the information contained herein neither replaces nor supplements the filings and service of pleading or other pages as required by law, except as provided by local rules of court. THE WESTERN DISTRICT OF PENNSYLVANIA:**

Pursuant to 28 U.S.C. §1441(a) and 28 U.S.C. §1446, Defendant Bath & Body Works, Inc. (incorrectly captioned as "Bath & Body Works/White Barn") ("Bath & Body") hereby removes this action from the Court of Common Pleas, Clearfield County, Pennsylvania, to this Court. The grounds for removal are:

1. This is a civil action brought by plaintiff Allstate Insurance Company as Subrogee of Sandra Simpson against Bath & Body in the Court of Common Pleas, Clearfield County, Pennsylvania, captioned *Allstate Insurance Company as Subrogee of Sandra Simpson v. Bath & Body Works/White Barn, Docket No. 04-1238-CS*. On or about August 23, 2004, Bath & Body was served with a copy of the Summons and Complaint, copies of which are attached hereto as Exhibit "A."

2. Clearfield County, Pennsylvania, the place where the pending action was originally filed, is within the geographic boundaries of the United States District Court for the Western District of Pennsylvania. 28 U.S.C. §118(a).

3. Bath & Body desires to exercise its rights under the provisions of 28 U.S.C. §1441, *et seq.*, to remove this action from the Court of Common Pleas, Clearfield County, to the United States District Court for the Western District of Pennsylvania.

4. This action filed by plaintiff in state court is removable to this Court under 28 U.S.C. §1441(a) as an action of which this Court has original jurisdiction under 28 U.S.C. §1332. Plaintiff at the time the aforesaid action was commenced was and still maintains its principal place of business in the state of Illinois and is incorporated in a state other than Delaware. Petitioner Bath & Body, at the time said action was commenced, was and still is a Delaware corporation with its principal place of business in the State of Ohio. There is therefore diversity of citizenship and the defendant is a citizen of a state other than Pennsylvania. The amount in controversy exceeds the sum or value of \$75,000, exclusive of interest, fees and costs. See Copy of the Complaint of Allstate Insurance Company, attached hereto as Exhibit "A" in which damages "in excess of \$100,000" are sought. Accordingly, this Court has original jurisdiction of this action under 28 U.S.C. §1332.

5. This Notice of Removal is timely filed pursuant to 28 U.S.C. §1446(b) in that it is filed within thirty (30) days of service of the Summons and Complaint on the defendant. See Copy of correspondence from plaintiff's counsel memorializing service of the Complaint, attached hereto as Exhibit "B."

6. Accordingly, this action is a civil action which may be removed to this Court pursuant to 28 U.S.C. §§1441(a) and 1446(b).

7. Defendant Bath & Body will file a Notice of the Filing of this Notice of Removal and a copy of the Notice of Removal with the Clerk of the Court of Common Pleas, Clearfield County, Pennsylvania, pursuant to 28 U.S.C. § 1446(d).

WHEREFORE, Bath & Body Works, Inc. (incorrectly captioned as BATH & BODY WORKS/WHITE BARN) respectfully requests that this Court assume jurisdiction over this case and issue such further orders and processes as may be necessary to bring before it all parties necessary for the trial hereof.



COMPLAINT

Plaintiff, Allstate Insurance Company, as subrogee of Sandra Simpson, by and through their attorneys, White and Williams LLP, by way of Complaint against defendant, Bath & Body Works/White Barn Candle Company, hereby states the following:

1. Plaintiff, Allstate Insurance Company (hereinafter "Allstate"), is a corporation organized and existing under the laws of the State of Illinois. Allstate is authorized to conduct business and does conduct business in the Commonwealth of Pennsylvania.

2. At all times relevant hereto, Sandra Simpson, is an adult individual who owns property located at 35 Mowery Lane, Dubois, PA 15801 and insured this property with a policy issued by Allstate.

3. Defendant, Bath & Body Works/White Barn Candle Company (hereinafter "Bath & Body Works"), upon information and belief is a corporation duly organized and existing under the laws of the State of Ohio and which does conduct business in the Commonwealth of Pennsylvania.

COUNT ONE
NEGLIGENCE
PLAINTIFF VS. DEFENDANT

4. On September 16, 2003, a fire occurred at property owned by Sandra Simpson, which was located at 35 Mowery Lane, Dubois, Pennsylvania.

5. As a direct and proximate result of this September 16, 2003 incident, the property owned by Sandra Simpson and insured by plaintiff, Allstate, suffered extensive damages.

6. The above mentioned damages were caused, and resulted from the negligent, reckless and careless acts and/or omissions of defendant, Bath & Body Works, in designing and manufacturing a candle which caused the fire, White Barn Candle Company Real Essence Cucumber Melon Candle, product number 0452Z8A4B. Said acts consisted of:

- (a) Negligent design of the candle's glass container which housed the candle;
- (b) Negligent manufacturing of the glass container which housed the candle;
- (c) Negligent testing of the glass container which housed the candle to make sure it could withstand high thermal temperatures; and
- (d) Was otherwise negligent in designing, manufacturing and testing the candle and the glass container which housed the candle.

7. The above referenced fire damage to Simpson's property was caused by, and resulted from, the negligence, carelessness, recklessness and other liability-producing conduct of defendant as previously set forth and incorporated herein by reference in paragraph 6.

8. As a direct and proximate result of the foregoing and pursuant to its policy of insurance with Sandra Simpson, plaintiff, Allstate, incurred expenses in excess of \$100,000.00 when it indemnified Simpson for claims made under her policy due to the fire damage.

9. Pursuant to the application of the policy deductible, Sandra Simpson sustained uninsured losses of \$250.00.




