COMPLAINT

1. Plaintiff is a corporation with offices at P.O. Box 1244, Englewood Cliffs, NJ 07632.
2. Defendant is an adult individual residing at RR 2 BOX 234, MORRISDALE, PA 16858.
3. Defendant applied for and received a credit card issued by Plaintiff's assignor bearing the account number 4465690400741474 .
4. Defendant made use of said credit card and has currently a balance due and owing to Plaintiff, as of August 4, 2004, in the amount of \$4,477.28.
5. Defendant is in default of the terms of the cardholder Agreement having not made monthly payments to Plaintiff thereby rendering the entire balance immediately due and payable.
6. Plaintiff avers that the Cardholder Agreement between the parties provides that Plaintiff is entitled to the addition of finance charges at the rate of 6% per annum on the unpaid balance.
7. Although repeatedly requested to do so by Plaintiff, Defendant has willfully failed and/or refused to pay the principal balance, finance charges or any part thereof to Plaintiff.

WHEREFORE, Plaintiff demands Judgment in its favor and against Defendant, Rebecca J. Bumbarger individually, in the amount of \$4,477.28 with continuing finance charges thereon at the rate of 6% per annum from date of judgment plus costs.



STIPULATION OF THE PARTIES FOR PAYMENT
AND FOR THE ENTRY OF JUDGMENT BY CONSENT

TO THE PROTHONOTARY:

Kindly enter Judgment in favor of Plaintiff and against the Defendant, Rebecca J. Bumbarger, above-named, in the amount of \$4,477.28 pursuant to the Stipulation of the Parties for Payment and for the Entry of Judgment by Consent, as follows:

1. Defendant admits indebtedness to Plaintiff in the amount of \$4,477.28 with continuing interest thereon at a rate of 6.00% per annum plus costs from the date of judgment.
2. To secure the repayment of said indebtedness, Defendant agrees that Judgment by Consent will be entered in favor of the Plaintiff and against the Defendant, Rebecca J. Bumbarger, in the amount of \$4,477.28 plus continuing interest thereon at the rate of 6.00% per annum from the date of judgment and costs.

3. Plaintiff agrees not to Execute on its Judgment so long as Defendant causes to be delivered to Plaintiff the following payments in full by 12:00 NOON on the following dates:

(a) \$175.00 due by September 25, 2004;

(b) no less than \$175.00 per month due on the 25th day of each consecutive month thereafter until the Judgment amount plus accrued interest and costs are paid in full.



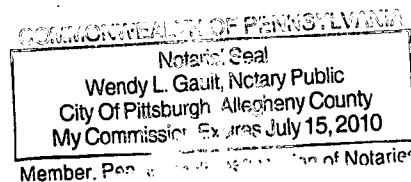
