STIPULATION AGAINST LIENS

WHEREAS, CLEARFIELD-LAWRENCE TOWNSHIP JOINT AIRPORT AUTHORITY (hereinafter "OWNER"), is about to execute contemporaneously herewith, a contract with **GLENN O. HAWBAKER, INC.** (hereinafter "CONTRACTOR") of 1952 Waddle Road, State College, Centre County, Pennsylvania, to perform the labor necessary for the **Rehabilitation of Runway 12-30 (Contract No. 19)** located at the Clearfield-Lawrence Township Airport in Clearfield County, Pennsylvania.


NOW, THEREFORE, at the time of and immediately before the execution of the contract between OWNER and CONTRACTOR, and before any authority has been given by OWNER to the said CONTRACTOR to perform the labor necessary for the construction, or to purchase materials for said construction, in consideration of the making of the contract for the construction between the OWNER and CONTRACTOR, it is agreed that neither the undersigned CONTRACTOR, any subcontractor, or material man, or any workman, or any other person, for labor furnished or materials purchased, shall file a lien, commonly called a Mechanic's Lien, for work done or materials furnished to the said building under the contract between the OWNER and CONTRACTOR for construction of the commercial building, the right to file, maintain or have such liens being expressly waived.
