COMPLAINT

1. That Plaintiff William G. Satterlee & Sons, Inc. is a Pennsylvania corporation with an office and place of business at 12475 Route 119, Rochester Mills, PA 15771 ("Satterlee").

2. That Defendant John M. Bakaysa is an individual who operates a gas station called B & B Service, situate on Route 36, in the Borough of Mahaffey, Pennsylvania 15757 ("Bakaysa").

3. That Bakaysa has purchased gas, diesel fuel, and other petroleum products from Satterlee under an open account.


4. That Satterlee has delivered gas, diesel fuel, and other petroleum products to Bakaysa under the open account. A copy of the balance due as of August 30, 2004, is attached hereto as Exhibit "A."

6. That Satterlee has demanded that Bakaysa pay the outstanding balance, which Bakaysa has failed and refused to pay.


