

AND NOW comes your Petitioner, Annmarie Emigh, on behalf of her minor child,
Morgan Taylor Musselman, by and through her counsel, John A. Sobel, IV, Esquire, who avers
as follows:

1. That your Petitioner is Annmarie Emigh, of P.O. Box 97, Drifting, Pennsylvania,
Clearfield County, 16834.
2. That your Petitioner is the natural mother of the minor child, Morgan Taylor Emigh,
who was born on December 7, 2000, as so evidenced by a copy of her birth certificate, which will
be presented to the Court at hearing.
3. That the natural father of the child is David Bass, of 964 Main Street, Winburne,
Clearfield County, Pennsylvania, 16879.
4. That the natural father does pay support for the care of the child through the Domestic
Relations Office of Clearfield County.
5. That your Petitioner has always referred to the minor child as Morgan Taylor Emigh,
rather than Morgan Taylor Musselman, since the day of the child's birth.
6. That the child has always understood that her name is Morgan Taylor Emigh and is not
familiar with the name Morgan Taylor Musselman.

7. That the child is getting older and will soon be of age to attend pre-school as well as kindergarten and elementary school.

8. That it is the desire of your Petitioner that the child's name be changed from Morgan Taylor Musselman to Morgan Taylor Bass Emigh in order that the child not be confused or suffer any undue stress stemming from her last name being different from her natural mother's.

9. That your Petitioner has contacted the natural father and advised him of her desire to change the name of Morgan Taylor Musselman to Morgan Taylor Bass Emigh.

10. That the natural father, David Bass, has no objection to the Court changing the name of the child from Morgan Taylor Musselman to Morgan Taylor Bass Emigh.


11. That the natural father will be given notice of this hearing.


13. That notice of today's proceeding will be advertised by publication as directed by your Honorable Court.
