COMPLAINT

AND NOW, comes the Plaintiff, by and through his attorney, Mary L. Pothoven, Esq., and brings this Complaint of which the following is a concise statement:

GENERAL ALLEGATIONS AS TO ALL COUNTS

1. The Plaintiff, Jason W. Witherite, is a sui juris adult who resides at Box 11, Luthersburg, Clearfield County, Pennsylvania 15848.

2. The Defendant, William E. Brady, is a sui juris adult who resides at RD #4, Box 634, DuBois, Clearfield County, Pennsylvania 15801.

3. The Defendant, Karen S. Brady, is a sui juris adult who resides at RD #4, 634, DuBois, Clearfield County, Pennsylvania 15801.

4. That at all times material to the within Complaint, the Defendants, William E. Brady and Karen S. Brady, were husband and wife.

5. That at all times material to the within Complaint the Defendants were the owners of a 1998 Ford pickup truck bearing Pennsylvania Title No. 1FTYR10C6WPA56081 and Pennsylvania License Plate No. YLG4326, being operated by Defendant, William E. Brady. Hereinafter said vehicle will be referred to as the Brady vehicle.

6. That on September 15, 2002, Defendant, William E. Brady, was operating the Brady vehicle in a northerly direction on State Route No. 255 in Sandy Township, Clearfield County, Pennsylvania.

7. That at all times material to the within Complaint Plaintiff, Jason W. Witherite, was the operator of a 1985 GMC pickup truck towing a race car on a trailer. Said pickup truck bears Pennsylvania Title No. 1GTGC33J9FS510047 and Pennsylvania License Plate No. YGH7490. Hereinafter said vehicle will be referred to as the Witherite vehicle.

8. That at all times material to the within Complaint, the Witherite vehicle was disabled, blocking both lanes of traffic

on State Route 255 and Plaintiff was outside the Witherite vehicle working on it to clear the traffic lanes.

9. That on September 15, 2002, the Defendant, while operating the Brady vehicle in a northerly direction on State Route 255, failed to bring his vehicle to a stop, colliding with the Witherite vehicle/trailer, pushing the trailer unit of the Witherite vehicle into Plaintiff, Jason W. Witherite.

10. The foregoing collision involving the Brady vehicle and the Witherite vehicle/trailer and all of the injuries and damages set forth herein sustained by the Plaintiff, were the direct and proximate result of carelessness, recklessness, and negligence of the Defendant, William E. Brady.

11. The Witherite vehicle/trailer was violently impacted in the collision with the Brady vehicle.

12. As a direct and proximate result of the collision, the Plaintiff, Jason W. Witherite, suffered various injuries including, but not limited to: concussion, contusion, abrasions, compound fracture of his right leg.

13. As a direct and proximate result of his injuries, the Plaintiff, Jason W. Witherite, has suffered emotional and physical suffering, inconvenience and agony and will continue to suffer the same indefinitely into the future.

14. As a direct and proximate result of said injuries, the Plaintiff, Jason W. Witherite, has incurred and in the future

will incur various expenses and bills for necessary and reasonable medical services and treatment in an effort to care for and alleviate his injuries.

15. Because of said injuries, Plaintiff, Jason W. Witherite, was prevented from attending to his usual duties and vocation, all to his great damage and loss.

16. Because of said injuries, the Plaintiff's general health, strength and vitality has been impaired and diminished and will continue to be so indefinitely into the future and his ability to enjoy and live a full and beneficial life has been impaired and diminished and will continue to be so indefinitely into the future.

17. As a result of the injuries he suffered and as the result of a need to seek medical care and treatment for the injuries he suffered which were caused by the Defendant, William E. Brady; Plaintiff, Jason W. Witherite, has suffered a loss of earnings.

18. As a result of the collision, Plaintiff, Jason W. Witherite, has incurred various miscellaneous expenses.

19. Because of said injuries, the Plaintiff, Jason W. Witherite, has suffered permanent bodily injuries resulting in permanent physical limitations.

COUNT I.

JASON W. WITHERITE VS. WILLIAM E. BRADY, DEFENDANT, NEGLIGENCE

20. Paragraphs 1 through 19 are incorporated herein by reference and made a part hereof.

23. The collision was solely, jointly and severally the result of the recklessness, carelessness and negligence, of the Defendant, William E. Brady, in that he:

- a) operated his vehicle in an inattentive manner;
- b) failed to pay proper attention to the operation of his vehicle and disregard the safety and position to others;
- c) operated his vehicle in disregard to the position and safety to others;
- d) operated his motor vehicle in a careless, reckless and negligent manner;
- e) failed to have his vehicle under control so as to be able to stop within the assured clear distance ahead;
- f) operated his vehicle at a speed greater than was reasonable under the circumstances;
- g) failed to operate his vehicle with due regard to the highway, weather and traffic conditions which existed or which he was aware of or should have been aware of;
- h) failed to have his vehicle under proper and adequate control so as to prevent his vehicle from striking the Witherite vehicle;

i) failed to apply brakes in time to avoid the collision;

j) improperly applied his brakes;

k) permitted or allowed his vehicle to strike and collide with the side of the Witherite vehicle/trailer;

l) failed to keep a reasonable lookout for other vehicles lawfully on the road;

m) failing to use due care under the circumstances;

n) failing to notice the Witherite vehicle was stopped in the lane of travel;

o) failing to take evasive action to avoid impacting with the Witherite vehicle.

WHEREFORE, the Plaintiff, Jason W. Witherite, prays for a judgment against Defendant, William E. Brady, in an amount exceeding \$25,000.00 and such other relief as Your Honorable Court deems appropriate.

COUNT II.
JASON W. WITHERITE VS. KAREN S. BRADY, DEFENDANT
NEGLIGENCE IMPUTED

22. Paragraphs 1 through 21 are incorporated herein by reference and made a part hereof.

23. On the date and time the collision occurred, the Defendant, Karen S. Brady, was the co-owner of the Brady vehicle being operated by the Defendant, William E. Brady.

24. That on the date and at the time the subject collision occurred the Defendants, William E. Brady and Karen S. Brady, were engaged in a common enterprise.

25. That on the date and at the time the subject collision occurred although the Defendant, William E. Brady, was operating the Brady vehicle, the Defendant, Karen S. Brady, had the right to share in the control of the Brady vehicle.

26. In the alternative, the Brady vehicle was being maintained by Defendants for the benefit of the family unit, including themselves.

27. That on the date and time the subject collision occurred, the Brady vehicle was being operated by the Defendant, William E. Brady, for the benefit of the family unit, including themselves.

28. That on the date and time the subject collision occurred, the Brady vehicle was being operated by the Defendant, William E. Brady, for a family purpose benefiting both himself and the Defendant, Karen S. Brady.

29. That in the alternative at the time the subject collision occurred, Defendant, William E. Brady's, operation of the Brady vehicle as heretofore indicated was as an agent, servant, workman or employee of Defendant, Karen S. Brady, engaged in her business.

30. That the recklessness, negligence and carelessness of the Defendant, William E. Brady, is therefore imputed to the Defendant, Karen S. Brady, with her being liable for the damages herein being requested.

WHEREFORE, Plaintiff, Jason W. Witherite, prays for judgment against Defendant, Karen S. Brady, in an amount exceeding \$25,000.00 and requests such other relief as Your Honorable Court deems appropriate.





ANSWER WITH NEW MATTER TO PLAINTIFF'S COMPLAINT

AND NOW, come Defendants William E. Brady and Karen S. Brady, by and through their counsel, McQuaide, Blasko, Schwartz, Fleming & Faulkner, Inc., and file the following Answer with New Matter to Plaintiff's Complaint.

1. Denied. After reasonable investigation, Defendants lack sufficient knowledge or information to form a belief as to the truth of the allegations in paragraph 1. The same are therefore denied and strict proof thereof demanded.
2. Admitted.
3. Admitted.
4. Admitted.
5. Admitted, with the exception that 1FTYR10C6WPA56081 refers to the Vehicle Identification No., and not the Pennsylvania Title No.
6. Admitted.

7. Admitted on information and belief, with the exception that 1GTGC33J9FS510047 refers to the Vehicle Identification No. on Plaintiff's truck, and not the Pennsylvania Title No.

8. Admitted in part and denied in part. Defendants admit only that at the time Defendant William Brady first encountered the Witherite vehicle, the vehicle and trailer being towed by Plaintiff were blocking both travel lanes of State Route 255 in their entirety, thus creating a sudden hazard for oncoming traffic such as Defendant William Brady, and that Plaintiff was outside the Witherite vehicle at that time. Defendants deny that the Witherite vehicle was disabled at all times material to this action. To the contrary, on information and belief, Defendants aver that before the Witherite vehicle and trailer were stopped in the road completely obstructing travel on State Route 255, Plaintiff had been driving the vehicle in an easterly direction on Route 420, and that Plaintiff skidded through the posted stop sign on Route 420 and crashed into the guardrail on State Route 255, causing his vehicle and attached trailer to become attached to the guardrail and completely block travel on State Route 255.

9. Admitted in part and denied in part. It is admitted only that, upon seeing the Witherite vehicle and trailer in the road, Defendant William Brady could not stop in time to avoid a collision with the 29 foot long trailer, which, together with Plaintiff's truck, was completely blocking Defendant's path on State Route 255. On information and belief, it is further admitted that upon the collision, the trailer unit of the Witherite vehicle was pushed into Plaintiff. Any implication that Defendant William Brady could have stopped his vehicle in time to avoid collision with the obstruction created by Plaintiff's vehicle and trailer in the roadway is denied. To the contrary, due to road conditions and the hazard created by Plaintiff, Defendant William Brady was unable to stop in time to avoid the collision, despite the exercise of due care.

By way of further response, a vehicle belonging to a third party, not named as a party in this action by Plaintiff, was parked along State Route 255 facing oncoming northbound traffic with the headlights on. The headlights from this vehicle, which was parked between the complete roadway obstruction Plaintiff had created and oncoming northbound traffic, created a blinding hazard, interfering with the ability of northbound drivers, such as Defendant William Brady, to perceive the hazardous condition Plaintiff had created on State Route 255. On information and belief, Defendant avers that Plaintiff acted in concert with the third party owner of this vehicle in creating the blinding hazard, thereby exacerbating the hazardous condition Plaintiff had already created and preventing Defendant William Brady from perceiving the hazardous condition in sufficient time to stop his vehicle to avoid it.

10. Denied. All allegations of negligence are denied pursuant to Pennsylvania Rule of Civil Procedure 1029(e). Additionally, after reasonable investigation, Defendants are without sufficient knowledge or information to form a belief as to the truth of the averments regarding Plaintiff's injuries and damages. The same are therefore denied and strict proof thereof demanded.

11. Admitted in part and denied in part. It is admitted that there was significant impact between the Brady vehicle and the trailer being hauled by the Witherite vehicle. It is denied that there was any impact between the Witherite vehicle and the Brady vehicle. Any violent impact to the Witherite vehicle occurred when Plaintiff skidded through the stop sign on State Route 420 and collided with the guide rail on State Route 255 with sufficient force to attach his vehicle to the guiderail.

12. - 16. Denied. After reasonable investigation, Defendants are without sufficient knowledge or information to form a belief as to the truth of the averments of paragraphs 12

through 16 pertaining to Plaintiff's allegations of injuries and damages. The same are therefore denied and strict proof thereof demanded.

17. Denied. After reasonable investigation, Defendants are without sufficient knowledge or information to form a belief as to the truth of the averments in paragraph 17 regarding Plaintiff's alleged injuries and damages. The same are therefore denied and strict proof thereof demanded. Plaintiff's allegation that Defendant William Brady was the cause of any injuries allegedly suffered by Plaintiff is denied. To the contrary, any such injuries were caused by the negligence, carelessness and/or recklessness of Plaintiff and/or third persons.

18. - 19. Denied. After reasonable investigation, Defendants are without sufficient knowledge or information to form a belief as to the truth of the averments of paragraphs 18 and 19 regarding Plaintiff's alleged injuries and damages. The same are therefore denied and strict proof thereof demanded.

COUNT I
JASON W. WITHERITE vs. WILLIAM E. BRADY, DEFENDANT, NEGLIGENCE

20. Defendants incorporate by reference paragraphs 1 - 19, above, as though set forth in full.

23. a - o. Denied. All allegations of recklessness, carelessness and negligence on the part of Defendant William E. Brady are denied pursuant to Pennsylvania Rule of Civil Procedure 1029(e). Defendant William E. Brady denies any recklessness, carelessness, and/or negligence in the operation of his vehicle. The collision between the Brady vehicle and the Witherite trailer was solely the result of the negligence, recklessness, and/or carelessness of Plaintiff and/or third parties not in the control of Defendants. By way of further response, please see paragraphs 1 - 19, above, and Defendants' New Matter, set forth below.

WHEREFORE, Defendants William E. Brady and Karen S. Brady respectfully request that Plaintiff's Complaint be dismissed, with prejudice and costs of suit.

COUNT II
JASON W. WITHERITE vs. KAREN S. BRADY, DEFENDANT
NEGLIGENCE IMPUTED

22. Defendants incorporate by reference paragraphs 1 - 21, above, as though set forth in full.

23. Admitted.

24. Denied. By way of further response, Defendant William Brady was traveling to work at the time of the accident. Defendant Karen Brady was not present in the vehicle.

25. Admitted in part and denied in part. Defendants do not know what is intended by the phrase "had the right to share in the control of the Brady vehicle." All allegations regarding the same are therefore denied and strict proof thereof demanded. Karen Brady was not in the vehicle at the time of the accident. It is admitted only that Defendant William E. Brady was operating the Brady vehicle on the date and time of the collision at issue.

26. Denied. Defendants do not know what is intended by the phrase "maintained by Defendants for the benefit of the family unit." The allegations regarding the same are therefore denied and strict proof thereof demanded to the extent such allegations are relevant, which is denied.

27. Denied. Please see response to paragraph 26 above. Any implication that Defendant Brady was acting as an agent, servant, and/or employee on behalf of Defendant Karen Brady at the time of the collision is denied.

28. Denied. Please see response to paragraph 26 above. Any implication that Defendant Brady was acting as an agent, servant, and/or employee on behalf of Defendant Karen Brady at the time of the collision is denied.

29. Denied.

30. Denied. It is denied that Defendant William Brady was reckless, careless, and/or negligent. The balance of the allegations in paragraph 30 constitutes a legal conclusion to which no response is required. To the extent that a response is deemed required, the allegations are denied and strict proof thereof demanded. It is denied that any basis exists for imputing negligence to Defendant Karen Brady.

NEW MATTER

31. Defendants incorporate by reference paragraphs 1 - 30, above, as though set forth in full.

32. Defendants hereby raise and assert all those defenses and/or limitations on damages available to them by reason of the terms and provisions of the Pennsylvania Motor Vehicle Financial Responsibility Law, as amended.

33. To the extent Plaintiff was insured under a policy of insurance bearing the limited tort option, Plaintiff's claims are barred or reduced accordingly.

34. To the extent Plaintiff's medical expenses and wage loss, if any, have been paid or are payable under a policy of insurance, the same may not be plead, proven or recovered in the instant action.

35. Defendants hereby raise the sudden emergency doctrine.

36. Defendants hereby raise and assert the defenses of contributory negligence, comparative negligence and/or assumption of the risk by Plaintiff.

37. On information and belief, Defendants aver that Plaintiff was negligent, careless and/or reckless in the operation of his vehicle and trailer, which carelessness, recklessness and/or negligence resulted in the complete obstruction of both travel lanes of State Route 255 and created a hazard for oncoming traffic, such as Defendant William Brady.

38. Plaintiff was further negligent in failing to take any steps to warn oncoming vehicles of the total obstruction in the roadway created by reason of his negligence, carelessness, and/or recklessness or to otherwise take reasonable precautions for the safety of himself and others, and also in failing to properly equip the trailer he was hauling so as to enhance its visibility to other traffic.

39. On information and belief, Defendants aver that Plaintiff was negligent in operating his vehicle and attached trailer while intoxicated at the time of the events at issue in this matter.

40. Plaintiff's cause of action and alleged damages claimed were caused in whole or in part by a third party who is not a party to this action.

41. On information and belief, Defendants aver that after Plaintiff's initial negligent acts resulting in the complete obstruction of State Route 255, a third party, not named as a party to this action, parked a vehicle on the side of State Route 255, with its headlights on and facing oncoming northbound traffic on State Route 255, thereby creating a blinding hazard to oncoming traffic and interfering with the ability of oncoming vehicles to perceive the hazardous condition on State Route 255 caused by Plaintiff's vehicle and trailer, and preventing oncoming traffic from avoiding a collision with the same.


42. On information and belief, Defendants aver that Plaintiff was acting in concert with the third party referenced in paragraph 41, above.





**DEFENDANTS WILLIAM E. BRADY AND KAREN S. BRADY'S MOTION
TO COMPEL PLAINTIFF'S ANSWERS TO INTERROGATORIES
AND REQUEST FOR PRODUCTION OF DOCUMENTS**

1. The Plaintiff instituted this automobile negligence action via Writ of Summons issued on September 10, 2004. On December 14, 2004, a Complaint was filed.
2. Defendants filed an Answer with New Matter in response to Plaintiff's Complaint on January 10, 2005.
3. Plaintiff Jason Witherite seeks damages in excess of \$25,000.00 for injuries he allegedly sustained in a motor vehicle accident that occurred on September 15, 2002 at the intersection of State Routes 420 and 255 in Clearfield County, Pennsylvania.
4. On November 19, 2004, Defendants served Interrogatories and Request for Production of Documents Directed to Plaintiff (Set One). (See Interrogatories and Request for Production (Set One) attached hereto as Exhibit "A").
5. As per Pennsylvania Rule of Civil Procedure 4006(b), the Interrogatories and Request for Production (Set One) requested Plaintiff to respond to said discovery requests within thirty (30) days of service of the same. (See Exhibit "A").

6. On December 23, 2004 Plaintiff's counsel requested a thirty (30) day extension within which time to answer said discovery requests. (See correspondence dated December 23, 2004 attached hereto as Exhibit "B").

7. Defendants agreed to Plaintiff's request for an extension via correspondence dated December 28, 2004, which set forth the new discovery deadline of January 18, 2005. (See correspondence dated December 28, 2004 attached hereto as Exhibit "C").

8. As no responses were received by the above deadline, Defendants contacted Plaintiff's counsel indicating that Plaintiff had not answered the Interrogatories or Request for Production of Documents. (See correspondence dated January 27, 2005 attached hereto as Exhibit "D").

9. Plaintiff served his first set of Interrogatories and Request for Production directed to Defendants on January 17, 2005. Defendants filed timely responses to said requests on February 18, 2005.

10. On March 31, 2005 Plaintiff's counsel was again requested to provide full and complete responses to the Interrogatories and Request for Production and informed that Defendants would have no alternative but to file a Motion to Compel in the event that Plaintiff's responses were not forthcoming. (See correspondence dated March 31, 2005 attached hereto as Exhibit "E"). Throughout this time period, Plaintiff's counsel was also contacted via telephone regarding this issue. Plaintiff's counsel repeatedly promised that said discovery responses would be forthcoming and yet failed to provide the same.

11. Most recently, Plaintiff's counsel indicated that Plaintiff would provide full and complete responses to the Interrogatories and Request for Production "by and not later than June 10." (See correspondence dated May 27, 2005 attached hereto as Exhibit "F"). After Plaintiff

failed to meet the June 10, 2005 deadline, Plaintiff's counsel was granted one more week in order to comply by correspondence of June 14, 2005. (See correspondence dated June 14, 2005 attached hereto as Exhibit "G").

12. As of the date of this Motion, over six (6) months have expired and the Plaintiff has failed to provide responses to the Interrogatories or Request for Production of Documents.

13. Plaintiff has not filed any objections to the outstanding discovery requests which are the subject of the instant Motion.

14. Defendants in this matter have produced discovery responses and documents, and Plaintiff has had the benefit of the same.

15. Plaintiff is delaying this case by his continual failure to provide responses to Defendants' discovery requests.

16. Defendants are prejudiced in the preparation of a defense to Plaintiff's claims. The requested information that has not been provided would assist Defendants in accurately assessing the case, conducting the necessary investigation inquiries, conducting expert review and preparing for depositions of the parties and completing further discovery in preparing a defense to this action.





A. "You" and/or "your" means Plaintiff, her agents and employees and others acting on her behalf with regard to asserting the cause of action to be set forth in Plaintiff's Complaint in the above-captioned case.

B. "Document" shall mean any writing (whether handwritten, typed, printed or otherwise made), drawing, graph, chart, photograph, phonograph record, videotape, or electronic or mechanical matter (including microfilm of any kind or nature, tape or recording), or other data compilations from which information can be obtained (translated, if necessary, by Defendant, through detection devices into reasonably usable form), and shall include, without limiting the generality of the foregoing, all records, correspondence, telegrams, teletypes, agreements, studies, reports, drafts, memoranda, and computer print outs.

C. As used herein "identify", when used in reference to an individual, means her full name and present or last known residence and business address, her present or last known position or title and business affiliation, and his position at the time in question.

D. "Health care provider" means a person, corporation, facility, institution or other entity licensed or approved by the Commonwealth to provide health care or professional services as a physician, including a medical doctor and a doctor of osteopathy and a doctor of podiatry; hospital; nursing home; health maintenance organization; or an officer, employee or agent of any of them acting in the course and scope of his employment.
