**WHEREAS**, Owner is the owner of property located at 10 Lakeside Avenue, Dubois, PA 15801, Clearfield County, as described at Instrument No. 200302102 ("Property"); and

**WHEREAS**, Contractor has agreed to make certain improvements upon the property in connection with renovations and remodeling.

**NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:** That in consideration of the premises, and of the terms and conditions of the Contract above mentioned, and in compliance with the Mechanics' Lien Law of 1963, Act of August 24, 1963, P.L. 1175, 43 P.S. § 1101, et seq., and § 1402, as amended (the "Act"), and with the intent that the parties hereto be legally bound hereby, the Owner and Contractor do covenant, stipulate and agree as follows:


It is specifically agreed by and between the parties that the Contractor shall not file nor will it permit or suffer any subcontractor, materialman, mechanic or other person under it to file, nor shall the Contractor or any subcontractor, materialman, or other person file any mechanics' or other lien or claim for work done or material furnished in or about the excavation or construction of any improvements whatsoever to the Property, or for any extra work performed in connection therewith against the Property or against any structures, improvements or fixtures thereon erected or to be erected, or against any structures, improvements, fixtures or other property whatsoever; and Contractor does hereby agree to defend, indemnify and hold Owner harmless for and against all such claims or liens, if any such liens are filed against Owner and/or the Property.

It is the full intent of the Contractor, and the Contractor does by the execution hereof, for itself, its successors and assigns, and for any subcontractor, materialman, mechanic or other person claiming for himself, itself or themselves waive the right to file a mechanics' lien or other lien or claim against the Owner and/or Property for work done, or materials furnished in connection with construction of a residence on or improvements to the Property or any extra work performed in connection therewith.



**THE SECOND THEREOF: BEGINNING** at an iron pipe at the Southeast corner of lands of the DuBois Country Club; thence along lands of the DuBois Country Club, North 10° 10' East a distance of 506.5 feet to an iron pipe; thence North 51° 57' East a distance of 239.1 feet to an iron pipe; thence North 6° 43' East a distance of 202.0 feet to an old road; thence North 68° 54' West a distance of 187.3 feet to an iron pipe; thence North 6° 00' East a distance of 18.0 feet to an iron pipe; thence South 89° 20' West a distance of 683.3 feet to an iron pipe; thence North 70° 10' West a distance of 331.0 feet to an iron pipe on the boundary line between Sandy Township and City of DuBois; thence along said boundary line East a distance of 2020 feet more or less to the center line of the Pennsylvania Electric Company transmission line; thence along said transmission line, South 15° 30' East a distance of 490.0 feet more or less to a point; thence continuing along said transmission line, South 15° 30' East a distance of 490° feet more or less to a point; thence continuing along said transmission line, South 3° 08' East a distance of 816.0 feet more or less to a point; thence South 89° 20' West a distance of 1364.0 feet more or less to a point: thence North 10° 10' East a distance of 100.0 feet to the place of beginning. Containing approximately 36 acres. more or less.

**UNDER AND SUBJECT TO**, and with reversions and restrictions following: said premises may be used only for recreational purposes of the Grantee, a non-profit enterprise, and if the same be used for any other purpose, or if there be cessation or abandonment of said use, title thereto shall revert to and be vested in the City of DuBois; there is excepted and reserved all timber of a merchantable nature, which timber shall be cut only under the supervision of the City of DuBois, the same to be cut at the sole expense of the said Grantee, and shall be subject to use or sale or otherwise as the said City shall direct, any profits therefrom running to the sole benefit and use of the said City.

**BEING** the same premises which were conveyed to the DuBois Country Club by deed of the City of DuBois, dated June 14, 1956 and recorded at Clearfield, Pennsylvania, in Deed Book No. 471, page 535.

As far as possible all rights of mining and drilling, and ingress, egress and regress, shall be exercised so as not to interfere with the development or use of the property as a recreational facility.
