4030 Motor Vehicle Property Damage

1. Plaintiff is an insurance company licensed and authorized to do business in the Commonwealth of Pennsylvania with one of its principle places of business at the above captioned address.
2. Defendant is an adult individual and at all times pertinent hereto resided at the above captioned address.
3. On December 13, 2001, Plaintiff's insured, Avonelle Snyder, was involved in an accident with Defendant.
4. Thereafter, Plaintiff did accept liability for this loss.
5. On or about February 13, 2002, Plaintiff did issue payment to Defendant Lawson for the amount of \$2, 213.81 for the damages to his motor vehicle.
6. Thereafter, Plaintiff realized it owed Defendant Lawson's lien holder, DuBois Financial, so Plaintiff advised Defendant Lawson and Defendant Lawson agreed to pay to DuBois Financial the \$2, 213.81 check which it should have received.

7. Thereafter, DuBois Financial advised Plaintiff that Defendant Lawson had not paid DuBois Financial.
8. Plaintiff then on or about May 8, 2002 paid Dubois Financial \$2, 213.81.
9. Plaintiff has made demand upon Defendant Lawson to reimburse Plaintiff in the amount of \$2, 213.81.
10. Defendant Lawson has refused to reimburse Plaintiff.

WHEREFORE, Plaintiff demands judgment for \$2, 782.42 plus interest and costs of suit.
