



***SUGGESTED DEED DESCRIPTION
FOR LANDS OF

First Thereof:

All that certain piece or parcel of land situated in the Township of Beccaria, County of Clearfield, Commonwealth of Pennsylvania, bounded and described as follows:

Beginning at a point on the center line of Pennsylvania State Route SR-2002, said point being the southeast corner of lands of Lanetta M. Potutschnig as described in Instrument Number 200407980, said point being the southwest corner of the parcel herein conveyed and running;

1 thence along the lands of Lanetta M. Potutschnig and also along the lands of Christine Bowie as described in Instrument Number 200208482 and along an existing tree line / fence line / hump row north 24 degrees 03 minutes 11 seconds west passing through a $\frac{1}{2}$ " pipe (found) at a distance of 181.48 feet and continuing on for a total distance of 328.19 feet to a fence post (found);

2 thence along the southern line of lands of Christine Bowie north 72 degrees 21 minutes 14 seconds east a distance of 390.96 feet to a point;

3 thence along the line of lands of Deborah A. Beginning at a fence post on the southern line of lands of Samuel Serian as described in Instrument Number 199919708, said fence post being on the western line of an unnamed street, said place of beginning being the northeast corner of the parcel herein conveyed and running;


1. thence along the western right of way line of an unnamed street south 13 degrees 57 minutes 06 seconds east a distance of 380.29 feet to a point, said point being the north east corner of lands of Deborah A. Ballaratto as described in Deed Book 768 page 252;
