1. Petitioner is James A. Naddeo, Esquire, attorney of

2. Respondent is Joel P. Kraus Plaintiff in the above-

3. That your Petitioner was originally consulted by
Respondent on December 10, 2004 concerning an automobile accident
in which he was involved on December 6, 2002.

4. That because of the eminent running of the statute
of limitations, Petitioner recommended that a Praeclipe for Writ Of


12. That your Petitioner obtained additional extension of time from counsel for Sidorick in order to accommodate the conference to be held with Respondent on June 30, 2005.
