**PETITION FOR COURT ORDERED TITLE**

1. Petitioner is Rick A. Sheeder, a resident of Clearfield County, Pennsylvania, specifically 1608 Powell Avenue, Hyde, PA, 16843.
2. Petitioner is one of three registered owners listed on the Certificate of Title for a Vehicle, a copy of which is attached hereto as Exhibit "A."
3. The vehicle is a Mobile Home VIN CJ9565A, being a 1985 Commodore with Title Number 37104 201504 RI, issued January 15, 1992.
4. The other two registered owners, hereafter "Decedents" or "Respondents," are:  
Gerald W. Kennedy and  
Evelyn E. Kennedy
5. The Decedents are the former father-in-law and mother-in-law of Petitioner. Petitioner was married to their only child, a daughter, Evelyn Marie Kennedy Sheeder, now Evelyn Hays, also a Respondent herein.

6. Petitioner and Respondent Evelyn M. Sheeder are divorced, having been married from August 22, 1992 until entry of their Divorce Decree on August 8, 1996, in Clearfield County Number 96-277-CD. One child was born of the marriage:

Katherine M. Sheeder, date of birth: October 13, 1993.

7. The Decedents co-signed on a loan for Petitioner to purchase the referenced mobile home prior to the marriage of Petitioner and Defendant Evelyn Marie Kennedy Sheeder, now Hays.

8. Neither Petitioner nor his daughter (who resides with him) have had any contact whatsoever with Evelyn Marie Kennedy Sheeder Hays for the past six years, since September 1998, except to receive harassing telephone calls from her shortly thereafter, a record of which was made with the Lawrence Township Police.

9. Petitioner alone has timely and properly paid all payments due under the installment contract on the referenced mobile home with final payment having been made in the summer of 2004, and with the lien released September 2, 2004.

10. Title was erroneously issued by the mobile home company, Family Mobile Homes, Inc., of Altoona, PA, in three names instead of Petitioner's name alone; Family Mobile Homes, Inc. would not issue a corrected Certificate of Title.

11. A search of the U.S. Social Security Death Index indicates that Decedents died as follows:

Evelyn E. Kennedy, date of death: October 5, 1999

Gerald W. Kennedy, date of death: April 4, 2002

Copies of the search results are attached as "Exhibit B-1" and "Exhibit B-2."

12. A death certificate on Evelyn E. Kennedy from Missouri is attached as "Exhibit C."

13. Missouri did not have a death certificate for Gerald W. Kennedy. A letter confirming this from the Missouri Department of Health is attached as "Exhibit D."

14. The last known address of Decedents' only daughter is:


15. The Post-Nuptial Agreement of Petitioner and Evelyn Marie Sheeder dated March 13, 1996, in Paragraph 5, states as follows:

**DIVISION OF MOBILE HOME AND REAL ESTATE:** The parties hereto acknowledge that the Husband was possessed of a mobile home prior to the parties' marriage and as of the execution date of this Agreement, Husband continues to hold this mobile home *in his name alone* and Wife, therefore, agrees to make no claim of any nature or for any changes in value to the mobile home which may have occurred for any reason during the course of the parties' marriage. The parties are not possessed of any real estate. *(Emphasis added.)*

16. Petitioner has entered into a Contract to sell the referenced Mobile Home subject to the contingency of obtaining clear title to same.
17. Involuntary transfer is recognized in 75 PA Stat. Section 1116 (b).

**WHEREFORE**, Petitioner prays this court to:

- 1.) Issue a Court Order of Involuntary Transfer into Petitioner, and declaring him sole and rightful owner of the 1985 Commodore Mobile Home VIN CJ9565A;
- 2.) Order such Notice as the law requires;
- 3.) Provide such other and further relief as the Court deems just and proper.

8. 
15. The Post-Nuptial Agreement of Petitioner and Evelyn Marie Sheeder dated March 13, 1996, in Paragraph 5, states as follows:
