COMPLAINT

AND NOW, come the Plaintiffs, John D. De Carli and Dora A. De Carli, by and through their attorneys, Evey, Routch, Black, Dorezas, Magee & Levine LLP, and file the following Complaint:

1.

Plaintiff, John D. De Carli, is an adult individual with a mailing address of P. O. Box 25, Byrnedale, Elk County, Pennsylvania 15827.

2.

Plaintiff, Dora A. De Carli, is an adult individual with a mailing address of P. O. Box 25, Byrnedale, Elk County, Pennsylvania 15827.

3.

Defendant, Michael A. Starr, is an adult individual residing at 501 Main Street, Brockway, Jefferson County, Pennsylvania 15824.

4.

On or about May 21, 2003, Plaintiffs were the owners of a 1999 Chevrolet Malibu motor vehicle which was involved in the accident described herein.

5.

On that date, Defendant was the owner of a 1997 Ford F150 pickup motor vehicle

which was involved in the accident described herein.

6.

On the aforesaid date, at approximately 11:00 a.m., Plaintiffs' motor vehicle was parked and unoccupied in a careful, lawful and prudent manner in the parking lot of Rosses Greenhouse, Dubois, Clearfield County, Pennsylvania.

7.

On the aforesaid date and time, Defendant was operating his motor vehicle in a careless, reckless and negligent manner in the parking lot of Rosses Greenhouse, Dubois, Clearfield County, Pennsylvania.

8.

As the motor vehicle being operated by Defendant backed from its parking spot and approached Plaintiffs' parked and unoccupied vehicle, said motor vehicle, suddenly and without warning, carelessly, negligently and recklessly came into violent contact and collision with the front end of the motor vehicle of the Plaintiffs, causing damages as more specifically set forth below.

9.

The motor vehicle of the Plaintiffs was damaged solely, directly and entirely as a result of the aforesaid collision in the amount of \$1,972.17, being less than the fair market value of the motor vehicle of the Plaintiff at the time of the collision.

COUNT I

PLAINTIFFS V. MICHAEL A. STARR

10.

Paragraphs 1-9 are incorporated by reference herein as if the same had been set forth at length.

The aforesaid accident was directly and proximately caused by the carelessness, recklessness and negligence of the Defendant, which consisted of the following:

- a. Failing to have the motor vehicle under proper, adequate, and reasonable control under the circumstances and conditions then and there existing;
- b. Operating his motor vehicle at an excessive rate of speed under the circumstances;
- c. Operating the motor vehicle without due regard for the right, safety and position of the parked and unoccupied motor vehicle of the Plaintiffs at the time and place aforesaid;
- d. Failing to see and observe the parked and unoccupied motor vehicle of the Plaintiffs in sufficient time to avoid the damages to said motor vehicle of the Plaintiffs;
- e. Being inattentive and disregarding the condition and circumstances then and there existing;
- f. Operating a motor vehicle in such a way as to negligently and carelessly collide with the parked and unoccupied motor vehicle of the Plaintiffs;
- g. Failing to take evasive action in order to avoid impacting with Plaintiffs' parked and unoccupied vehicle;
- h. Failing to apply his brakes in sufficient time to avoid striking Plaintiffs' parked and unoccupied vehicle;
- i. Driving his vehicle with careless disregard for the safety of persons or property in violation of 75 Pa.C.S.A. §3714;


j. Failing to back his vehicle in such a manner so as to be able to stop before colliding with Plaintiffs' parked and unoccupied vehicle in violation of 75 Pa. C.S.A. §3702; and

k. Violating the laws and statutes of the Commonwealth of Pennsylvania pertaining to the control of speed, management, and operation of the motor vehicle in the Commonwealth.

WHEREFORE, Plaintiffs claim damages of Defendant in the amount of One Thousand Nine Hundred Seventy-Two and 17/100 (\$1,972.17) Dollars, together with interest plus costs of suit.
