COMPLAINT

AND NOW, comes N. GEORGE BLOOM, JR., and SANDRA WESTON, by
and through their attorney, R. DENNING GEARHART, who avers as follows:

1. That Plaintiff, N. GEORGE BLOOM, JR., is an adult individual, with
an address of Box 304, Juniata Avenue, Houtzdale, Clearfield County, Pennsylvania
16651.

2. That Plaintiff, SANDRA WESTON, is an adult individual, with an address of 120 Swope Road, West Sunbury, PA 16061.

3. That Defendant ISABELLA BLOOM, passed away with a last known residence being in Jordan Township, Clearfield County, Pennsylvania; her estate having been probated with the Register of Wills for Clearfield County to Estate No. 5344.

4. That Defendants HERBERT W. BLOOM; JOHN C. BLOOM; WILLIAM D. BLOOM; JENNIE BLOOM; EMMA REA; and BLANCHE BLOOM DICKEY, were the children of Isabella Bloom, are believed to have passed on with last known residences being unknown; this belief is based on the time that has passed since the last evidence of their existence and is formulated after search of the telephone records, post office records and records at the Clearfield County Courthouse failed to mention any reference to Herbert W. Bloom; John C. Bloom; William D. Bloom; Jennie Bloom; Emma Rea; and Blanche Bloom Dickey.

5. That Defendant, S.H. WITHEROW (ESTATE), is believed to have passed on. This belief is based on the time that has passed since the last evidence of his existence and is formulated after search of the telephone records, post office records and records at the Clearfield County Courthouse failed to mention any reference to S.H. Witherow Estate formerly of Jordan Township, Clearfield County, Pennsylvania.

6. That the property in question is more particularly described below and has the Tax Map Nos. 120-H15-20, 120-H15-19, and 120-999-6:

ALL that certain parcel of seated lands situate in the Township of Jordan, Clearfield County, Pennsylvania, containing one and one-half acres (1 1/2 A); ten and three-fourths acres (10 3/4 A); and ten acres (10 A) surface, and sold as the property of John C. Bloom.

Said property was more recently surveyed by Henry Surveys, Port Matilda, PA, and is described as follows:

ALL that certain tract of land situate in the Township of Jordan, County of Clearfield, State of Pennsylvania, being bounded and described as follows according to a plan and survey thereof made by Henry Surveys dated May 12, 1980:

BEGINNING at a spike in the center of Pa. Rt. 857 in line of lands of J. Harris; thence along the center of said road the following three courses and distances: (1) North Nine (9) degrees Fifty-two (52) minutes Twenty-five (25) seconds West, One Thousand Seventy-five and fourteen hundredths (1,075.14') feet to a point of curvature in the center of Pa. Rt. 857; thence (2) along an arc to the left having a radius of One Thousand Four Hundred Seventeen and one hundredths (1417.01') feet a distance of Three Hundred Ninety-seven and thirty-seven hundredths (397.37') feet to a point of tangency; thence (3) along this tangent North Twenty-five (25) degrees Fifty-six (56) minutes Twenty-eight (28) seconds West, One Hundred Fifty (150.0') feet to a spike in line of lands of N. Irwin; thence along the same North Fifty-three (53) degrees Forty-one (41) minutes Twenty-three (23) seconds East, Seventy-six and thirty-six (76.36') feet to an iron pin in line of lands of H. B. Francis; thence along the same South Thirty-six (36) degrees Sixteen (16) seconds Two (02) minutes East, One Thousand Six Hundred Sixty-three and Ninety hundredths (1663.90') feet to an old post and witnesses found; thence South Sixty-seven (67) degrees Forty-nine (49) minutes Fifty-three (53) seconds West, Seven Hundred Twenty-seven and eighty-six hundredths (727.86) feet to the first mentioned point and place of beginning. CONTAINING 13.45 Acres of land.

ALSO

ALL that certain lot or tract of land situate in the Township of Jordan, County of Clearfield, State of Pennsylvania, being bounded and described as follows according to a plan and survey thereof made by Henry Surveys dated May 12, 1980:

BEGINNING at an iron pin on the West side of Pa. Rt. 857 in line of lands of M. Dotts; thence South Sixty-eight (68) degrees Twenty-six (26) minutes Six (06) seconds East, Thirty-two and sixteen hundredths (32.16') feet to a point in the center of Pa. Rt. 857; thence along the center line of said road the following three courses and distances: (1) along an arc to the South having a radius of Seven Hundred Fifty-nine and Fifty-seven hundredths (759.57') feet an arc distance of One Hundred Sixty-seven and seventy-two (167.72') feet to a point of tangency; thence (2) along this tangent South Thirty-four (34) degrees Thirteen (13) minutes Zero (00) seconds West, Three Hundred Thirty-four and eleven hundredths (334.11') feet to a point of curvature of an arc to the left having a radius of Ninety-five and ninety-four hundredths (95.94') feet; thence (3) along this arc a distance of Ninety-one and three hundredths (91.03') feet to a point; thence South Sixty-nine (69) degrees Fifty-one (51) minutes Seventeen (17) seconds West, Forty and eighty-nine hundredths (40.89') feet to an iron pin in line of lands of R. Glasgow; thence along the

same North Thirty-nine (39) degrees Ten (10) minutes Seven (07) seconds West, Three Hundred Sixty-four and fourteen hundredths (364.14') feet to an iron pin in line of lands of J. Harris; thence along the same North Fifty-three (53) degrees Forty-one (41) minutes Twenty-one (21) seconds East, Five Hundred Sixty-one and twenty-one (561.21') feet to the first mentioned point and place of beginning.
CONTAINING 1.96 Acres of land.

7. That said property was obtained by George Bloom and Sandra Weston, by Deed dated June 12, 1975 and entered for record in the Recorder's Office of Clearfield County to Deed Book 717, Page 134.

8. That said property was seized and taken from John C. Bloom for delinquent taxes by the Treasurer of Clearfield County in 1936; sold by the Clearfield County Commissioners in 1942, and sold to Norman G. Bloom and Ruth H. Bloom by Deed dated May 25, 1942 and filed for record in the Recorder's Office of Clearfield County in Deed Book Volume 345, Page 119.

9. That said property was obtained by Isabella F. Bloom from Abraham Bloom and Mary, his wife, by Deed dated May 11, 1882 and found for record in the Recorder's Office of Clearfield County in Deed Book Volume 55, Page 110.

10. That Isabella F. Bloom passed away in 1910, and by her Will found for record in the Register of Wills Office of Clearfield County to Estate No. 5344 (Will Book H, Page 189), she gave all the property out of the 59 acre tract West of the road leading from Ansonville to Glen Hope to a son, Herbert W. Bloom, during his lifetime, with the property then reverting to his children, or if he had no children, then to John C. Bloom, William D. Bloom, Jennie Bloom; children of Emma Rea, and Blanche Bloom Dickey.

Under Isabella Bloom's Will, she also gave the property East of the public road from Ansonville to Glen Hope to John C. Bloom for his use. There was no provision in the Will for reversion after John C. Bloom ceased using the property.

11. Accordingly, it is averred that the property would have reverted to all of the Heirs of Isabella F. Bloom.

12. That it was found in the records that the property of Isabella Bloom became assessed by Clearfield County in 1912 to the individual heirs. Those assessments were incorrect. The heirs became assessed with an acreage instead of a fractional interest in the total 59 acres.

13. When John C. Bloom was assessed with the 10 3/4 acres (should have been coal or mineral rights), and 10 acres, the Treasurer of Clearfield County also sold the property for non-payment of taxes. The Treasurer sold 10 acres assessed to John C. Bloom to S.H. Witherow Estate by Deed dated December 13, 1928 and recorded in Clearfield County Deed Book 294, Page 222. The Treasurer sold 10 3/4 acres assessed to John C. Bloom to S.H. Witherow Estate by Deed dated December 13, 1928 and recorded in Clearfield County Deed Book 294, Page 223. The chain of title out of S.H. Witherow Estate never shows this property listed in his estate or estates of heirs of the estate, nor was the property ever assessed to Witherows.

14. That with respect to this property, Plaintiffs and their predecessors in title have exercised open, notorious and continuous dominion possession and control over the premises described in Paragraph 6 for a period in excess of 21 years adverse to any other claims of ownership.

15. That with respect to this property, Plaintiffs and their predecessors in title believed this was conveyed to them and as a result of that belief, they have maintained it by paying taxes thereon.

16. That the purpose of this Quiet Title Action is to extinguish and cure any defects which may exist in the ownership of property more particularly described in Paragraph 6 hereof, and to extinguish any equity which the Defendants, their heirs, successors and assigns may have in the premises described in Paragraph 6 hereof.

17. That the Defendants, their heirs, successors and assigns identified in Paragraphs 3 through 5 of this Complaint are the only persons or entity known to Plaintiff who have any interest in said property and the Defendants, their heirs, successors and assigns cannot be determined if they/it continue(s) to exist. All the public records in the Clearfield County Courthouse and local telephone books have been checked prior to reaching this conclusion.

WHEREFORE, Plaintiff requests:



or in any way attaching the Plaintiff's title to said property, from issuing or maintaining an ejectment from said premises and from encumbering, mortgaging or conveying the said premises or any part thereof.

C. such other relief as the court determines to be equitable and just.
