5. That your Petitioner alleges that the aforesaid Democratic Nomination Petition of Robert Kiel does not contain the required number (100) of genuine signatures of electors entitled to sign said nominating petition under Pennsylvania Law as follows:
6. That Elector # 7, Paul Vargo, 548 Locust Street, DuBois, is not a registered voter in Magisterial District 46-3-01, Petitioner asks that the Elector's signature be discounted as invalid.

WHEREFORE, Petitioner prays that your Honorable Court order, decree and adjudge that the Democratic Nomination Petition of Robert C. Kiel as a candidate for Magisterial District Court Judge 46-3-01 shall be set aside as not containing a sufficient number of genuine signatures of qualified electors entitled to sign said nominating Petition under applicable Pennsylvania law and as such that the name of Robert C. Kiel be prohibited from appearing as a Democratic candidate for said office on the 2005 primary ballot and that the Clearfield County election officials should be so restrained.

7. Robert C. Kiel, who is known to me, answered the door and invited me into his home at which point I handed him certified copies of the PETITION, ORDER and my ENTRY

OF APPEARANCE.

8. I briefly explained the nature of the proceedings and requested him to contact me if he, or if he elected to be represented by counsel, counsel to contact me regarding any stipulations we might be able to agree upon prior to hearing.

9. I left the Kiel residence, walked back home and had dinner.



