

COMPLAINT

And now, comes the Plaintiff, Berkley Mid-Atlantic Group, by and through its counsel, Shapira, Hutzelman, Berlin, & May, and files this Complaint against the Defendant, Justin Powell, a statement of which is as follows:

1. The Plaintiff, Berkley Mid-Atlantic Group, is an insurance company, duly authorized to insurance customers in the Commonwealth of Pennsylvania, with an address of P.O. Box 27707, Richmond, Virginia 23261.
2. The Defendant, Justin Powell, is an adult individual residing at or having a place of business at 197 Electric Avenue, Houtzdale, Pennsylvania 16651.
3. The Defendant, Justin Powell, is the owner of Electric Avenue Banquet and Functional Hall, Inc.
4. A lawsuit was filed against Electric Avenue Banquet and Functional Hall, Inc. by Paula Shomo in the Court of Common Pleas of Clearfield County at Case No. 2001-00422 C.D.
5. The Plaintiff, Berkley Mid-Atlantic Group, was Electric Avenue Banquet and Functional Hall, Inc.'s insurance carrier, at the time the cause of action arose in the lawsuit described above.
