NOW COMES the Petitioner, Joshua J. Berndt, by his Attorneys, Belin & Kubista, petitions the Honorable Court for the change of name of his minor child, Chloe A. Veoni, and avers as follows:

1. That Petitioner is Joshua J. Berndt, and adult individual residing at 1405 West Hannah Street, Houtzdale, Clearfield County, Pennsylvania, 16651.
2. That Chloe A. Veoni is one (1) year old (d.o.b. 10/2/03) and was born out of wedlock to Petitioner and Erin N. Veoni, natural father and natural mother.
3. That upon her birth, Chloe A. Veoni was given the name of her mother.
4. That the Petitioner desires to legally change the name of his daughter, Chloe A. Veoni, in order that the child may bear her father's name.
5. That during the course of the child's life, she has resided with her mother and her maternal grandparents at 316 Filbert Street, Curwensville, Clearfield County, Pennsylvania, 16833, except for a three (3) month period of time from November, 2004, until February, 2005, when the child resided with Petitioner and mother at Petitioner's residence at 1405 West Hannah Street, Houtzdale, Clearfield County, Pennsylvania, 16651.
6. Petitioner has had regular contact with the child by informal agreement of the parties, and has filed a custody action in this Court seeking the entry of an order

providing regular periods of partial custody. In addition, Petitioner has provided financial support since the child's birth by making direct payments to mother, and now makes support payments through the Clearfield County Domestic Relations Office in accordance with a court order entered with the consent of both parents.

7. There are no judgments or decrees of record or any other matter of like character against Chloe A. Veoni.

WHEREFORE, Petitioner respectfully requests that the Honorable Court, pursuant to the Act of December 16, 1982, P.L. 1309, No. 295, Section 2, 54 Pa.C.S.A. § 701, to set a hearing on this Petition for purposes of considering a decree to change the name of Chloe A. Veoni to Chloe A. Berndt.
