AND NOW, comes Your Petitioner, Richard Michael Miller Augenbaugh, by and through his attorney, Richard H. Milgrub, Esquire, who requests that the Court Order a change of name for him, pursuant to 54 Pa.Cons.Stat.Ann. Section 701, et. seq., and in support thereof, represents as follows:

1. Your Petitioner, Richard Michael Miller Augenbaugh, is a resident of DuBois, Pennsylvania and has resided at the following locations during the five years (5) next preceding the filing of this Petition: For the one year (1) previous to the filing of this Petition, Your Petitioner resided at 47 1/2 East Long Avenue, DuBois, Pennsylvania 15801. For the preceding four years (4), Your Petitioner resided at 2010 15th Avenue, Altoona, Pennsylvania 16601.

2. Prior to November 19, 1979, Your Petitioner's mother, Pamela Augenbaugh, married Frederick Augenbaugh. Following said marriage, on November 19, 1979, a Petition for Name Change was filed requesting the Court to change Your Petitioner's legal name from Richard Michael Miller to Richard Michael Augenbaugh.

3. On December 11, 1979, a Decree was entered legally

changing Your Petitioner's name from Richard Michael Miller to Richard Michael Miller Augenbaugh.

4. Subsequent to this change of name, Your Petitioner's mother, Pamela Augenbaugh, and Frederick Augenbaugh were divorced.


5. Your Petitioner wishes to retake his original legal name of Richard Michael Miller.
