4. The prices charged for the services were the fair and reasonable market prices of the same at the time they were provided to the Defendant, and further are the prices the Defendant agreed to pay.

5. Plaintiff has demanded payment of the balance due as set forth on Plaintiff's Invoice of Defendant's account, Exhibit "1", of Two Thousand Four Hundred Four and 33/100 Dollars (\$2,404.33), but Defendant has failed and refused to pay the same or any part thereof.

6. By the terms of sale, Plaintiff is entitled to interest at a rate of 6% per annum which became due and payable from an average due date of August 31, 2004.

WHEREFORE, the Plaintiff requests judgment in its favor, and against Defendant, JAK Transportation, Inc. in the amount of \$2,404.33 with interest at six percent (6%) from August 31, 2004 together with costs.
