

REPORT OF MASTER IN DIVORCE

TO THE HONORABLE JOHN J. PENTZ, PRESIDENT JUDGE OF SAID COURT:

The undersigned Master, appointed by your Honorable Court to take the testimony of the witnesses in the above entitled case and return the same, together with form of decree, respectfully reports as follows:

I. SCHEDULE

Complaint filed September 29, 1961.

On September 30, 1961, the complaint was personally served upon the Defendant, Paul Henry Hoopsick, in Clearfield, Pennsylvania.

On October 26, 1961, James K. Nevling was appointed Master.

The Master's Hearing was fixed for Tuesday, December 12, 1961, at 1:30 o'clock P. M. in the offices of Nevling and Davis on the second floor of the Clearfield Trust Company Building in Clearfield, Pennsylvania. Notice of the Master's Hearing was accepted by copy by John K. Reilly, Jr., Attorney for the Plaintiff, on November 21, 1961, and ^{notice of} the Master's Hearing was served upon the Defendant, personally, on November 25, 1961.

The Master's Hearing was held in the offices of Nevling and Davis in the Clearfield Trust Company Building on Tuesday, December 12, 1961, at 1:30 o'clock P. M. There appeared John K. Reilly, Jr., Esquire, Attorney for Plaintiff, Ethel Jean Hoopsick, the Plaintiff, and Paul Phillips, witness for the Plaintiff. No appearance was made either in person or by counsel for the Defendant.

II. SERVICE OF PROCESS

The complaint was personally served upon the defendant by Sheriff Charles G. Ammerman.

III. CAUSE OF DIVORCE

Desertion.

IV. FINDINGS OF FACT

1. The plaintiff and defendant were lawfully married on November 26, 1953, in Goshen Township, Clearfield County, Pennsylvania, by Rev. Walter Boreing of the Church of God.

2. At the time of the marriage the plaintiff and defendant were residents of Decatur Township, Clearfield County, Pennsylvania, and maintained their legal residence there from November 26, 1953, the date of the marriage, until the defendant was discharged from the service on December 13, 1954. From December of 1953 to December 13, 1954, they had maintained a temporary residence in North Carolina where the defendant was stationed while in the service. After the defendant was

discharged in December of 1954, the plaintiff and defendant moved to Niagara Falls in February or March of 1955. The defendant left the plaintiff in April of 1955. The plaintiff was a resident of Brisbin Borough, Clearfield County, at the time of the Master's Hearing, and the defendant a resident of Decatur Township.

3. Citizenship: The plaintiff and defendant are both citizens of the United States of America.

4. Age and occupation: The plaintiff is 26 years of age and is employed at Clear-Don Manufacturing Company in Philipsburg, Pennsylvania, and the defendant is 31 years old and his occupation is unknown.

5. Children: There were two children born to this marriage, Paul Henry Hoopsick, Jr., born May 26, 1954, and Evelyn Joyce Hoopsick, born October 7, 1955. Both of these children are living with the plaintiff at her home in Brisbin, Clearfield County, Pennsylvania.

6. Armed Forces: Neither the plaintiff nor the defendant is presently in the armed services of the United States nor were either of them in the armed services at any time material to this action.

7. Findings on the Merits: The Master finds the following facts:

(a) The parties were lawfully married on November 26, 1953.

(b) The plaintiff and the defendant were both residents of Decatur Township, Clearfield County, Pennsylvania, until February or March of 1955. At that time they moved to Niagara Falls, New York, and resided there

until the middle of April in 1955 when the defendant deserted the plaintiff. The plaintiff now resides at Brisbin, Pennsylvania, and the defendant resides in Decatur Township, Clearfield County, Pennsylvania.

(c) The defendant in mid-April of 1955 deserted the plaintiff without cause.

8. Discussion: Very little discussion is required in connection with the testimony in this case. The uncontradicted evidence is that the defendant deserted the plaintiff without cause and continued in that desertion from April of 1955 to December of 1961, a period of more than six years.

V. CONCLUSIONS OF LAW

1. The plaintiff and defendant are legally married and the marital relationship still subsists between them.

2. The parties are properly before the Court and the Court has jurisdiction.

3. The facts found establish grounds for divorce *a vinculo matrimonii*.

VI. RECOMMENDATION OF THE MASTER

The Master finds that the averments of the complaint relating to desertion are sustained by the proof and recommends that the prayer of the plaintiff be granted and that a decree be entered by your Honorable Court divorcing Ethel Jean Hoopsick, the plaintiff, and

Paul Henry Hoopsick, the defendant, from the bonds of matrimony now subsisting between them.

TO THE HONORABLE JOHN J. PENTZ, PRESIDENT JUDGE OF SAID COURT:

AND NOW, this 29th day of September, 1961, comes the Plaintiff, Ethel Jean (Phillips) Hoopsick, by her Attorney, William C. Chase, Esq., files this Action in Divorce of which the following is a statement:

1. The Plaintiff in this action is Ethel Jean (Phillips) Hoopsick and the Defendant is Paul Henry Hoopsick.
2. The Plaintiff, Ethel Jean (Phillips) Hoopsick resides at the home of her parents, Paul and Rebecca Phillips at Brisbin, Clearfield County, Penna.
3. The Plaintiff, Ethel Jean (Phillips) Hoopsick has resided in the Commonwealth of Pennsylvania, continuously since the time of her birth on December 7, 1935 and up to the time of and immediately preceding the filing of this Complaint in Divorce excepting for a period of time when the Plaintiff lived with her husband in Niagara Falls, New York from January, 1955 to April, 1955.
4. The Defendant, Paul Henry Hoopsick, is a citizen of the United States of America and has resided in the Commonwealth of Pennsylvania since the time of his birth, excepting for the period of time when he served in the Armed Forces of the United States of America from December 14, 1950 until his honorable Discharge therefrom on December 13, 1954 and excepting for a period of time when Defendant lived with his wife (Plaintiff herein) in Niagara Falls, New York from January, 1955 to April, 1955 and Defendant presently resides at Osceola Mills, R.D., Decatur Township, Clearfield County, Pennsylvania.

5. The Plaintiff herein was born at Brisbin, Clearfield County, Pennsylvania on December 7, 1935 and the Defendant herein was born at Osceola Mills R.D., Decatur Township, Clearfield County, Pennsylvania on January 23, 1931. Consequently, both Plaintiff and Defendant are in their majority.

6. The Plaintiff and Defendant herein were lawfully joined in marriage on November 26, 1953 at Brisbin, Clearfield County, Pennsylvania, by the Minister of the Brisbin Church of God, Brisbin, Pennsylvania.

7. There were two children born of this marriage - namely, Paul Henry Hoopsick, Jr., a son, who was born on May 26, 1954, and is presently seven years of age; and Evelyn Joyce, a daughter, who was born October 7, 1955, and is presently five years of age. Said children presently reside with their Mother, or the Plaintiff herein, Ethel Jean (Phillips) Hoopsick, at Brisbin, Clearfield County, Pennsylvania.

8. In violation of his marriage vows and of the laws of the Commonwealth, the Defendant, Paul Henry Hoopsick, did on or about the first day of April, 1955, willfully and maliciously and without reasonable cause, desert the Plaintiff and absented himself from their common habitation and has continued in said desertion since April 1, 1955 to the present time.

9. This action in Divorce filed by the Plaintiff, Ethel Jean (Phillips) Hoopsick, is not collusive.

10. The Plaintiff herein, Ethel Jean (Phillips) Hoopsick further avers that an action in divorce was commenced by Paul Henry Hoopsick against her to No. 480, February Term, 1959 and that said action in Divorce was discontinued on the 29th day of August, 1961, upon payment of all record costs.

WHEREFORE, the Plaintiff herein, Ethel Jean (Phillips) Hoopsick, prays that a Decree of Divorce "a vinculo matrimonii" be entered divorcing the Plaintiff from the bonds of matrimony heretofore existing between the parties hereto.

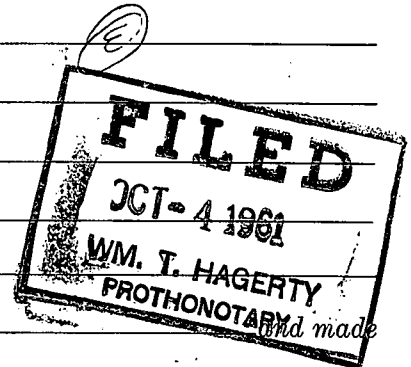

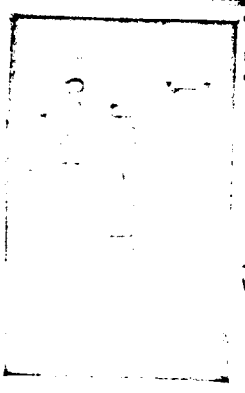



No appearance was made either in person or by
counsel for the defendant.

ETHEL JEAN HOOPSICK, being duly sworn according to law,
testified as follows:

BY MR. REILLY:

Q. Your name is Ethel Jean Hoopsick?

A. Yes.

Q. Before you were married, you were Ethel Jean
Phillips?

A. Yes.

Q. Now Mrs. Hoopsick, where were you married?
A. Church of God, Goshen Township.
Q. When were you married?
A. November 26, 1953.
Q. And by whom were you married?
A. Walter Boreing.
Q. And at that time you were married to Paul Henry Hoopsick?
A. Yes.
Q. And he is the defendant in this divorce action, is that correct?
A. Yes.
Q. And you are the plaintiff in this divorce action?
A. Yes.
Q. Now Mrs. Hoopsick, where are you living at present?
A. Brisbin, Pennsylvania.
Q. That's in Clearfield County?
A. Yes.
Q. Now Mrs. Hoopsick, where were you born?
A. Decatur Township.
Q. In Clearfield County, Pennsylvania?
A. Yes.
Q. And what was the date of birth?
A. December 7, 1935.
Q. And you lived in Decatur Township until you were married, is that correct?
A. Yes.
Q. Now, what is your age at present?
A. 26.

Q. Are you occupied, are you working?

A. I am working at the Clear-Don Manufacturing at Philipsburg.

Q. Now Mrs. Hoopsick, were there any children born of this marriage?

A. Two.

Q. Names and ages?

A. Paul Henry Hoopsick, Jr., May 26, 1954, that is date of birth, and Evelyn Joyce Hoopsick, October 7, 1955.

Q. Now Mrs. Hoopsick, are you a citizen of the United States?

A. Yes.

Q. And is your husband a citizen of the United States?

A. Yes.

Q. Now Mrs. Hoopsick, at the time of your marriage, where did you and your husband set up housekeeping?

A. He was in the service when we were married, I stayed home.

Q. While he was in the service you stayed home?

A. In December, I went down with him, in North Carolina.

Q. That's December of 53.

A. And he came back in March.

Q. Now, when he was discharged from the service, where did you live?

A. We stayed with his mother and then we went to Niagara Falls, New York.

Q. Do you remember what date he was discharged from the service?

A. December, I don't remember the date, December of 54.

Q. December 13, 1954.

Q. On what date did you move to Niagara Falls?

A. Must have been around the first of March or last of February, 1955. Only lived up there for about one month.

Q. Now Mrs. Hoopsick, where were you living when your husband left you?

A. Niagara Falls, New York.

Q. And what was the date that he left you?

A. Around the middle of April.

Q. 1955.

A. Yes.

Q. Now, since that time have you seen your husband?

A. I seen him a couple times but never talked to him.

Q. Did he ever offer to come back?

A. No.

Q. Did you give him any reason for leaving?

A. No.

Q. Then as far as you know, he left with his own accord and with no reason?

A. Yes.

Q. Have you lived with your husband since 1955?

A. No.

Q. Has there been any agreement between you and your husband as to the bringing of this action?

A. No.

Q. Have there been any former divorce actions filed between you and your husband?

A. One

Q. And who filed that divorce action?

A. He did, my husband.

Q. Now Mrs. Hoopsick, what was the outcome of the action filed by your husband in divorce?

A. It was discontinued.

Q. And I now show you a certificate of discontinuance to No. 480 February Term, 1959, in a divorce action by Paul Henry Hoopsick vs. Ethel Jean Hoopsick and ask you if that is the certificate of discontinuance in your husband's previous divorce action?

A. Yes.

Q. I would like to have the certificate of discontinuance entered as Plaintiff's Exhibit 1.

BY THE MASTER:

A. Plaintiff's Exhibit 1 is admitted in evidence.

Q. Mrs. Hoopsick, did you ever bring any proceeding against your husband to make him support you?

A. Just the children.

Q. Where did you bring the proceeding for the support of the children, in Clearfield County?

A. Yes.

Q. And was a decree made allowing you a support order for the children?

A. Yes.

Q. I think you testified you are a citizen of the United States, is your husband also a citizen of the United States?

A. Yes.

Q. What is your husband's present age and occupation?

A. I think he must be about 31, he is five years older than I am. I don't know his occupation.

Q. Where are your two children now living?

A. Living with me.

Q. Are you living with your father?

A. No, I have a home of my own.

Q. And is that in Decatur Township, is that where your home is?

A. It's in Brisbin.

Q. Mrs. Hoopsick, were either you or your husband in the military service when you began this divorce action.

A. No.

Q. Are either of you in the military service now?

A. No.

PAUL PHILLIPS, being duly sworn according to law, testified as follows:

BY MR. REILLY:

Q. Now Mr. Phillips, the plaintiff in this divorce action is your daughter, is that correct?

A. Correct.

Q. And you are acquainted with the defendant, Mr. Paul Henry Hoopsick?

A. Yes.

- Q. Now, since 1955 have the plaintiff and the defendant lived together, as to your knowledge?
- A. No.
- Q. Do you know if the plaintiff gave the defendant any reason for leaving her?
- A. No, no reason that I know off.
- Q. Do you know of any agreement between the plaintiff and the defendant for bringing this action of divorce?
- A. No.
