COMPLAINT

AND NOW comes the plaintiff, Virginia M. Stuller and witnesses, to complain against the defendant as follows:

(1) The plaintiff is a citizen currently residing at 27619 Dowlers rd. rt. 286 Glen Campbell Pa. 15742, Clearfield County.

**(2) The Defendants were negligent in the construction of the porch/deck.
(Attached is a letter from Brian Wruble (Clearfield County Building Inspector).**

(3) The defendants claimed that they were licensed, private contractors, and were fully knowledgeable of and aware of what the plaintiff wanted done to her home.

(4) The defendants did in fact construct a porch/deck, approx. 10x14'. The defendant was paid in full (\$ 3,972) for this, and then was taken to district court 46-3-04 and a judgment was passed against the defendant on Dec 16th 2002 in the amount of \$1,404.07 for overpayment.

(5) On or about June 11th 2002 Mr. and Mrs. Zidik received \$2,800 in cash for materials. Also on June 23rd they received a check for \$500.00.

(6) Mr. and Mrs. Zidik were contacted on the telephone several times between the months of July 2002 and October of 2002 to come and correct this problem. They failed to do so.

(7) Due to Mr. and Mrs. Zidiks negligence the porch/deck collapsed on or about the months of February and March of 2004 due to snowfall.

(8) Due to the structure collapsing it damaged the outside window frame and also the new screen door. And many items that were on the porch: Sunbeam gas grill, outside table and chairs and 3 lawn chairs.

COUNT 1 EX CONTRACTRACTU

(9) All of the above allegations are incorporated herein and made a part hereof.

(10) Inherent in the verbal contract of employment between the parties hereto was that the plaintiff was placing her home in the custody care and control of the defendants for building and repairing said porch/deck. The defendants agreed to repair/build porch/deck consistent with the instructions and request of plaintiff and to make certain that porch/deck was secure.

(11) In view of above allegations, the defendants breached his contractual duty as herein stated which caused the plaintiff to suffer a loss in the amount of \$5,980.00.

WHEREFOR, plaintiff demands judgment against the defendants in the amount of 5,980.00.

COUNT 2 NEGLIGENCE

(12) All of the above allegations are incorporated herein and made a part hereof.

(13) Due to the negligence of the defendants the plaintiff suffered a loss herein stated.

- a) The defendants being a bailee of the construction of the plaintiff's home failed to comply with Pennsylvania building construction codes. They also failed to obtain a building permit for the structure.**
- b) The defendants failed to take proper safeguards for building and property.**
- c) The defendants failed to use proper supplies and materials.**
- d) The defendants were notified about the instability of the structure and failed to correct it. By not building the structure correctly the defendants allowed the collapsing of the structure to happen.**

WHEREFORE, plaintiff demands judgment against the defendants in an amount less than \$7,000.

DEAR MS. STULLER,

IN REGARDS TO YOUR DECK AND ROOF COLLAPSING, I FOUND FAULT WITH THE STRUCTURAL ELEMENTS AND CONSTRUCTION OF THE STRUCTURE DURING MY INSPECTION ON APRIL 26, 2004. I FEEL THE FOLLOWING IS NOT ACCEPTABLE:

DECK AND FLOOR STRUCTURE

1. 2X6 FLOOR JOISTS 24 INCHES ON CENTER FOR A 14 FOOT SPAN WITH 2 THREE INCH NAILS FOR FASTENING
2. NO FOUNDATION SUPPORTS EXCEPT OUTSIDE CORNERS WHERE IT WAS FASTENED TO THE EXISTING STRUCTURE WITH TAP CONS. THE MIDDLE THIRD WAS THE ONLY SUPPORT DUE TO AN OFFSET ON THE FOUNDATION. THE OUTER FLOOR JOISTS' FACE BOARDS WERE TOE NAILED WITH TAP CONS, WHICH IS UNACCEPTABLE.
3. THERE WERE NO JOIST HANGERS ON HALF OF THE JOISTS. THE FASTENING OF ALL MATERIAL WAS BELOW STANDARDS.

ROOF STRUCTURE

1. 2X6 ROOF RAFTERS WITH A 14 FOOT SPAN WITH NO VISIBLE SUPPORT. WHERE THE ROOF RAFTERS WERE TIED IN TO THE EXISTING FASCIA BOARD, THE FASCIA BOARD WAS A 1X9 FOR SUPPORT AND VISIBLY ROTTEN. IT SHOULD HAVE BEEN REPLACED WITH 2 INCH LUMBER. THERE WERE NO RAFTER HANGERS AND IT WAS ONLY FASTENED WITH 2 THREE INCH NAILS WHICH WERE TOE NAILED WITH ONE ON EACH SIDE.

2. THE ROOF SHINGLES WERE NOT TIED IN TO THE EXISTING ROOF AND WERE NOT INSTALLED TO MEET THE MANUFACTURERS INSTALLATION INSTRUCTIONS.

IT IS IN MY OPINION THAT THE STRUCTURE WAS BUILT BELOW STANDARDS. IT WAS NOT BUILT TO WITHSTAND THE WEIGHT OF A 30 LB SNOW LOAD WHICH WE HAVE IN OUR CLIMATE. THE JOIST SYSTEM SHOULD HAVE BEEN BUILT WITH 2X8 LUMBER 16 INCHES ON CENTER, WITH A FOUNDATION GIRDER WITHIN THE SPAN OF THE FLOOR, WITH HANGERS AND FASTENED TO STANDARD. WHERE THE DECK CONNECTS TO THE EXISTING FOUNDATION, THE OFFSETS ON THE FOUNDATION SHOULD HAVE BEEN CORRECTED. THE EXISTING FASCIA BOARD SHOULD HAVE BEEN REPLACED AND THE RAFTERS SHOULD HAVE HAD TIE STRAPS AND FASTENERS TO STANDARDS, WITH A 2X8 DOUBLE HEADER FOR OUTER SUPPORT. THE ROOF SHINGLES SHOULD HAVE BEEN TIED IN TO THE EXISTING ROOF AND BEEN INSTALLED TO THE MANUFACTURERS REQUIREMENTS.

- (2) The Defendants were negligent in the construction of the porch/deck. (Attached is a letter from. Brian Wruble (Clearfield County Building Inspector).
- (3) The defendants claimed that they were licensed, private contractors, and were fully knowledgeable of and aware of what the plaintiff wanted done to her home.
- (4) The defendants did in fact construct a porch/deck, approx. 10x14'. The defendant was paid in full (\$ 3,972) for this, and then was taken to district court 46-3-04 and a judgment was passed against the defendant on Dec 16th 2002 in the amount of \$1,404.07 for overpayment.
- (5) On or about June 11th 2002 Mr. and Mrs. Zidik received \$2,800 in cash for materials. Also on June 23rd they received a check for \$500.00.

(6) Mr. and Mrs. Zidik were contacted on the telephone several times between the months of July 2002 and October of 2002 to come and correct this problem. They failed to do so.

(7) Due to Mr. and Mrs. Zidiks negligence the porch/deck collapsed on or about the months of February and March of 2004 due to snowfall.

(8) Due to the structure collapsing it damaged the outside window frame and also the new screen door. And many items that were on the porch: Sunbeam gas grill, outside table and chairs and 3 lawn chairs.

COUNT 1 EX CONTRACTRACTU

(9) All of the above allegations are incorporated herein and made a part hereof.

(10) Inherent in the verbal contract of employment between the parties hereto was that the plaintiff was placing her home in the custody care and control of the defendants for building and repairing said porch/deck. The defendants agreed to repair/build porch/deck consistent with the instructions and request of plaintiff and to make certain that porch/deck was secure.

(11) In view of above allegations, the defendants breached his contractual duty as herein stated which caused the plaintiff to suffer a loss in the amount of \$5,980.00.

WHEREFOR, plaintiff demands judgment against the defendants in the amount of 5,980.00.

COUNT 2 NEGLIGENCE

(12) All of the above allegations are incorporated herein and made a part hereof.

(13) Due to the negligence of the defendants the plaintiff suffered a loss herein stated.

a) The defendants being a bailee of the construction of the plaintiff's home failed to comply with Pennsylvania building construction codes. They also failed to obtain a building permit for the structure.

b) The defendants failed to take proper safeguards for building and property.

c) The defendants failed to use proper supplies and materials.

d) The defendants were notified about the instability of the structure and failed to correct it. By not building the structure correctly the defendants allowed the collapsing of the structure to happen.

WHEREFORE, plaintiff demands judgment against the defendants in an amount less than \$7,000.

IN REGARDS TO YOUR DECK AND ROOF COLLAPSING, I FOUND FAULT WITH THE STRUCTURAL ELEMENTS AND CONSTRUCTION OF THE STRUCTURE DURING MY INSPECTION ON APRIL 26, 2004. I FEEL THE FOLLOWING IS NOT ACCEPTABLE:

DECK AND FLOOR STRUCTURE

1. 2X6 FLOOR JOISTS 24 INCHES ON CENTER FOR A 14 FOOT SPAN WITH 2 THREE INCH NAILS FOR FASTENING
2. NO FOUNDATION SUPPORTS EXCEPT OUTSIDE CORNERS WHERE IT WAS FASTENED TO THE EXISTING STRUCTURE WITH TAP CONS. THE MIDDLE THIRD WAS THE ONLY SUPPORT DUE TO AN OFFSET ON THE FOUNDATION. THE OUTER FLOOR JOISTS' FACE BOARDS WERE TOE NAILED WITH TAP CONS, WHICH IS UNACCEPTABLE.
3. THERE WERE NO JOIST HANGERS ON HALF OF THE JOISTS. THE FASTENING OF ALL MATERIAL WAS BELOW STANDARDS.

ROOF STRUCTURE

1. 2X6 ROOF RAFTERS WITH A 14 FOOT SPAN WITH NO VISIBLE SUPPORT. WHERE THE ROOF RAFTERS WERE TIED IN TO THE EXISTING FASCIA BOARD, THE FASCIA BOARD WAS A 1X9 FOR SUPPORT AND VISIBLY ROTTEN. IT SHOULD HAVE BEEN REPLACED WITH 2 INCH LUMBER. THERE WERE NO RAFTER HANGERS AND IT WAS ONLY FASTENED WITH 2 THREE INCH NAILS WHICH WERE TOE NAILED WITH ONE ON EACH SIDE.

2. THE ROOF SHINGLES WERE NOT TIED IN TO THE EXISTING ROOF AND WERE NOT INSTALLED TO MEET THE MANUFACTURERS INSTALLATION INSTRUCTIONS.

IT IS IN MY OPINION THAT THE STRUCTURE WAS BUILT BELOW STANDARDS. IT WAS NOT BUILT TO WITHSTAND THE WEIGHT OF A 30 LB SNOW LOAD WHICH WE HAVE IN OUR CLIMATE. THE JOIST SYSTEM SHOULD HAVE BEEN BUILT WITH 2X8 LUMBER 16 INCHES ON CENTER, WITH A FOUNDATION GIRDER WITHIN THE SPAN OF THE FLOOR, WITH HANGERS AND FASTENED TO STANDARD. WHERE THE DECK CONNECTS TO THE EXISTING FOUNDATION, THE OFFSETS ON THE FOUNDATION SHOULD HAVE BEEN CORRECTED. THE EXISTING FASCIA BOARD SHOULD HAVE BEEN REPLACED AND THE RAFTERS SHOULD HAVE HAD TIE STRAPS AND FASTENERS TO STANDARDS, WITH A 2X8 DOUBLE HEADER FOR OUTER SUPPORT. THE ROOF SHINGLES SHOULD HAVE BEEN TIED IN TO THE EXISTING ROOF AND BEEN INSTALLED TO THE MANUFACTURERS REQUIREMENTS.

DEFENDANT'S PRELIMINARY OBJECTIONS TO PLAINTIFF'S COMPLAINT

AND NOW, come the Defendants, Charles and Kimberly Zidik, by and through their Attorney, Timothy S. Burns, Esq., and files the within Preliminary Objections to the Plaintiff's Complaint and in support thereof avers the following:

PRELIMINARY OBJECTION: ACTION BARRED PURSUANT TO
THE DOCTRINE OF RES JUDICATA

1. The allegations raised in the Plaintiff's Complaint were previously raised in a Complaint that the Plaintiff filed against the Defendants on October 11, 2002 before District Magisterial Judge James L. Hawkins. See complaint attached hereto, and marked as Defendants' Exhibit A.
2. Judge Hawkins entered judgment against the Defendants on December 16, 2002 for the amount of \$1,404.07. See order attached hereto, and marked as Defendants' Exhibit B.
3. Under the Doctrine of *Res Judicata*, there is identity of causes of action when in both the old and new proceedings the subject matter and the ultimate issues are the same.

4. The causes of actions in the present matter are identical to the causes of actions in the prior matter commenced by the Plaintiff. As such, the subject matter and ultimate issues remain the same.
5. Specifically, the Plaintiff is attempting to raise the same causes of actions, subject matter and ultimate issues in this present matter which have already been addressed by Judge Hawkins in a prior proceeding.
6. Thus, the Plaintiff's current Complaint is barred pursuant to the Doctrine of *Res Judicata*. WHEREFORE, the Defendants would respectfully ask this Honorable Court to dismiss the Plaintiff's Complaint with prejudice pursuant to the Doctrine of *Res Judicata* and also Pa. R.C.P. 1028(8).

**PRELIMINARY OBJECTION: FAILURE TO CONFORM TO LAW OR RULE OF
COURT PURSUANT TO PA. R.C.P. 1028(A)(2)**

1. The Plaintiff has filed a Complaint against the Defendants in the Court of Common Pleas of Clearfield County docketed at 05-782-CD.
2. On the cover sheet of the Plaintiff's Complaint, "Virginia M. Stuller and witnesses" is identified as "***Counsel*** for this Party". See copy of cover sheet attached hereto, and marked as Defendants' Exhibit C.
3. "Virginia M. Stuller and witnesses" is not a licensed attorney or law firm authorized to practice law in the Commonwealth of Pennsylvania.
4. The unauthorized practice of law in the Commonwealth of Pennsylvania is a criminal offense designated as a misdemeanor of the third degree per 42 Pa. C.S.A. § 2524.

5. The penalty for the unauthorized practice of law per 42 Pa. C.S.A. § 2524 applies to those individuals in this Commonwealth who hold themselves “out to the public as being entitled to practice law, or use or advertise the title of lawyer, attorney at law, attorney and counselor at law, *counselor*, or the *equivalent in any language*, in such a manner as to convey the impression that he [or she] is a practitioner of the law of any jurisdiction, without being an attorney at law...”
6. Virginia M. Stuller has held herself out as “counsel” to the Plaintiff in initiating litigation in the Court of Common Pleas of Clearfield County.
7. Plaintiff’s Complaint is an invalid legal document as it has been prepared, presented and filed by an individual alleging to be a proper counsel of record; however, not authorized to practice law in the Commonwealth of Pennsylvania.

WHEREFORE, the Defendants respectfully requests that this Honorable Court enter an Order dismissing the Plaintiff’s Complaint with prejudice for its failure to Conform to Law or Rule of Court pursuant to Pa. R.C.P. 1028(a)(2), specifically on the grounds that it has been filed by an individual holding herself as a counsel of record, though she is not authorized to practice law in the Commonwealth of Pennsylvania. In addition, the Defendants respectfully ask that this Honorable Court take any addition action which it deems appropriate against the Plaintiff.

**PRELIMINARY OBJECTION TO INCLUSION OF SCANDALOUS AND
IMPERTINENT MATERIAL PURSUANT TO PA. R.C.P. 1028(A)(2)**

1. The Plaintiff has filed a 2 count Complaint against the Defendants regarding the alleged construction of a porch/deck.

2. The Plaintiff has attached several documents to her Complaint which have no bearing or relevance to the allegations in her Complaint.
3. On Page 6 of the Complaint, the Plaintiff has attached a copy of a check for five hundred dollars (\$500.00) allegedly written by her to the Defendants. Such a check has no bearing or relevance to the allegations made in the Plaintiff's Complaint.
4. On Page 7 of the Complaint, the Plaintiff has attached a copy of a contracting proposal from Zadravec Contracting per construction at a property located at Rural Rt. 3, Box 275, Shelocta, PA 15774. Such a proposal has no bearing or relevance to the allegations made in the Plaintiff's Complaint.
5. On Page 8 of the Complaint, the Plaintiff has attached a copy of a report from a Brian Wruble of Guardian Inspection Services concerning a property located at PO Box 104, Glen Campbell, PA 15742. Such a proposal has no bearing or relevance to the allegations made in the Plaintiff's Complaint.

WHEREFORE, the Plaintiff would respectfully ask that this Honorable Court enter an Order striking the said documents from the Plaintiff's Complaint pursuant to Pa. R.C.P. 1028(a)(2) as they contain impertinent or irrelevant material.

PRELIMINARY OBJECTION PURSUANT TO PA. R.C.P. 1028(A)(3) FOR
INSUFFICIENT SPECIFICITY OF PLAINTIFF'S COMPLAINT

1. Paragraphs 1 through 8 of Plaintiff's Complaint allege that the Defendants were at fault for allegedly negligent construction of a porch/deck.
2. Pa. R.C.P. 1019(f) requires that "averments of time, place and items of special damages shall be specifically stated."

3. The aforementioned Paragraphs fail to state in any respect the time and/or dates of the alleged construction of the porch/deck, the alleged negligence by the Defendants in their alleged construction of the porch/deck, the alleged agreement to construct the porch/deck, and the alleged collapse of the porch/deck
4. The aforementioned Paragraphs fail to state the location and/site of the porch/deck.
5. Paragraph 13 of the Plaintiff's Complaint provides in part that "due to the negligence of the defendant's the plaintiff suffered a loss..."; "defendants...failed to comply with the Pennsylvania building construction codes"; "defendants failed to take the proper safeguards for building and property"; "defendants failed to use proper supplies and materials"; and "by not building the structure correctly the defendants allowed the collapsing of the structure to happen."
6. Pa. R.C.P. 1019(a) requires that the material facts on which a cause of action is based shall be stated in a concise and summary form.
7. The aforementioned Paragraph of the Plaintiff's Complaint fails to set forth with sufficient specificity the loss suffered by the Plaintiff, the construction codes which the Defendants allegedly fail to comply with, the proper safeguards for building and property that the Defendants allegedly failed to follow, what proper supplies and materials the Defendants allegedly failed to use, and finally, how the Defendants allegedly failed to properly construct the porch/deck.
8. Plaintiff's Complaint lacks sufficient specificity to apprise Defendants of the issues to be litigated, to allow them to adequately prepare and assert defenses to Plaintiff's allegations, and/or identify and join any potentially responsible parties as Additional Defendants.

WHEREFORE, the Defendants respectfully requests that this Honorable Court enter an Order striking Paragraphs 1-8 and 13 of Plaintiff's Complaint, and also strike Count 2 of Plaintiff's Complaint with prejudice.

PRELIMINARY OBJECTION: FAILURE TO STATE CLAIM UPON WHICH RELIEF

MAY BE GRANTED (COUNT 1: EX CONTRACTACTU)

1. Count 1 of the Plaintiff's Complaint fails to state a valid cause of action under Pennsylvania Law.
2. In Count 1, Plaintiff purports to make a claim for "Ex Contractactu". This claim does not exist under Pennsylvania Law
3. Because Plaintiff has failed in Count 1 to state a valid cause of action, the Court should dismiss Count 1 of the Plaintiff's Complaint.

WHEREFORE, the Defendants respectfully request that this Honorable Court enter an Order: (a) sustaining their Preliminary Objection pursuant to Pennsylvania Rule of Civil Procedure 1028(3) and 1028(4) for Plaintiff's failure to state a claim upon which relief may be granted; (b) dismiss Count 1 with prejudice; and (c) grant the Defendants such other relief as this Honorable Court deems appropriate.

PRELIMINARY OBJECTION: FAILURE TO STATE CLAIM UPON WHICH RELIEF


MAY BE GRANTED (COUNT 2: NEGLIGENCE)

1. In Count 2 of the Plaintiff's Complaint, the Plaintiff contends that due to the Defendants' negligence, the Plaintiff suffered a "loss".

2. To maintain a cause of action for negligence in the Commonwealth of Pennsylvania, a party must plead with specificity the following: (1) the duty or obligation recognized by law, requiring the actor to conform to a certain standard with respect to the injured party; (2) the actor's breach of that duty; (3) a causal connection between the actor's conduct and the resulting injury; and (4) actual damages.
3. In Count 2, the Plaintiff has not alleged what duty or obligation was owed her by the Defendants.
4. In Count 2, the Plaintiff has not alleged with specificity any breach of a duty owed by the Defendants.
5. In Count 2, the Plaintiff has not alleged with specificity any connection between the Defendants' conduct and the Plaintiff's alleged injuries.
6. In Count 2, the Plaintiff has not alleged with specificity actual damages.

WHEREFORE, the Defendants respectfully request that this Honorable Court enter an Order: (a) sustaining their Preliminary Objection pursuant to Pennsylvania Rule of Civil Procedure 1028(3) and 1028(4) for Plaintiff's failure to state a claim upon which relief may be granted; (b) dismiss Count 2 with prejudice; and (c) grant the Defendants such other relief as this Honorable Court deems appropriate.


4. In the event the Court does not ultimately grant
